DEFENSIVE DRIVING CLASS

If you qualify for the defensive driving diversion option, it may be applied to **only one** eligible traffic charge. You must appear in court or pay fines for any additional charges you received, on or within ten days before the appearance date on your complaint. If you receive an extension to complete a defensive driving class it <u>only</u> applies to the eligible charge.

ADVANTAGES:

- 1. You will not have to go to court for one traffic charge.
- 2. That charge will be dismissed.
- 3. You will receive no points against your license for that charge.
- 4. You will not have to pay a fine for that charge.

ELIGIBILITY:

You are eligible if you meet all of the following requirements:

- You have not attended a Defensive Driving Class in the State of Arizona for dismissal of a traffic charge within the past two years (violation date to violation date).
- 2. A violation code on your complaint matches one that is noted with an asterisk (*) on the FINE SCHEDULE.
- Your traffic charge did not result from an accident involving death or serious physical injury.
- 4. Your traffic charge has not already been set to trial or hearing.
- 5. You do not possess a Commercial Vehicle Class License.

- Complete the class at least seven business days prior to the court date written above your signature on the complaint.
- You <u>MUST</u> bring the following to the class:
 Driver's license, Copy of the complaint, Money Order/Cashier's Check

Failure to complete the defensive driving class AT LEAST SEVEN BUSINESS DAYS PRIOR to your court date may result in the issuance of a warrant for your arrest and/or driver license suspension with additional monetary penalties being imposed.

YOU MUST APPEAR IN COURT ON THE COURT DATE ON YOUR COMPLAINT IF:

- Any violation code on your complaint that does not appear on the fine schedule.
- Your complaint was issued as a result of an accident involving death or serious injury.

Failure to appear in court on or before the court date listed on your complaint may result in the issuance of a warrant for your arrest, and/or driver license suspension with additional monetary penalties being imposed as outlined in the below schedule.

FINE/SANCTION SCHEDULE

Listed below are VIOLATION CODES <u>with</u> fine amounts. Mandatory State Surcharges (83%) are included. **An asterisk (*)** indicates the violation is eligible for the Defensive Driving Class or the Bicycle Diversion Class if cited while riding a bicycle. If payment is not received by the court date provided on your ticket, there will be a \$20.00 Court Fee per case, plus an additional \$50.00 on <u>each</u> civil charge which is included in the Default Amount column below.

IMPORTANT NOTICE for individuals cited for:

A.R.S. 28-645A3A - Red Light Violation & A.R.S. 28-647.1 -Flashing Red Stop Signal: Persons found responsible or entering a plea of responsible, will be ordered by the Motor Vehicle Division (MVD) to attend and successfully complete Traffic Survival School (TSS). If you are eligible for defensive driving school and complete the class, the violation will be dismissed and you will not be subject to the requirement to attend a TSS class by the MVD.

A.R.S. 28-2532A - No Vehicle Registration. Mail or fax proof of current registration for reduced fine of \$199.00. Payment must be received by your court date.

A.R.S. 28-3169A - No Driver License in Possession. Dismissed upon proof of driver license valid on the date and time of the violation. A.R.S. 28-907A & B - Child Passenger Restraint. If you have been cited for "failure to use," or for "failure to equip", the fine is \$199.00. However, upon completion of a child safety course, offered through Tempe Police Department, the fine will be reduced to \$0.00 and you may receive a free child restraint system. For information, call 480-350-8376.

A.R.S. 28-4135A - No Mandatory Insurance. Fine ranges from \$1027.00 to \$1947.00. If you present proof of purchase of a 6 month current insurance policy and a copy of your MVD record showing no convictions for violating A.R.S 28-4135 within 24 months prior to the date the complaint was issued, or only one conviction for violating A.R.S 28-4135 within the 36 months prior to the date the complaint was issued the fine may be reduced to \$199.00.

A.R.S. 28-4135B & C - No Proof of Insurance. Fine ranges from \$1027.00 to \$1947.00. If you mail or fax proof showing that the vehicle involved was insured on the DATE and TIME the complaint was issued, the charge will be dismissed. If you present proof of purchase of a 6 month current insurance policy and a copy of your MVD record showing no convictions for violating A.R.S 28-4135 within 24 months prior to the date the complaint was issued, or only one conviction for violating A.R.S 28-4135 within the 36 months prior to the date the complaint was issued the fine may be reduced to \$199.00. If you are unable to provide proof of insurance for the DATE and TIME the complaint was issued, you must come to court on or within 10 days prior to your court date.

BICYCLE DIVERSION CLASS

If you have been cited for a City Code or Title 28 Moving Violation, while operating a bicycle, you may be eligible to attend a Bicycle Diversion Class for one eligible charge instead of paying the fine. However, you must appear at court or pay the fine for any additional charges you may have received, on or within ten days before the appearance date on your complaint.

ADVANTAGES:

- That charge will be dismissed.
- You will not have to pay the fine for that charge.

ELIGIBILITY:

- The violation was committed while operating a bicycle.
- Your bicycle charge has not already been set for a hearing.
