**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE,
ARIZONA, ESTABLISHING POLLING PLACES AND VOTING
DISTRICTS FOR THE MAY 20, 2014 SPECIAL ELECTION**

WHEREAS, a Special Election has been scheduled for May 20, 2014, for the purpose of submitting the City of Tempe General Plan 2040 to the voters for ratification; and,

WHEREAS, the Tempe City Code, Section 13-1, requires the City Council to establish polling places and voting districts by resolution no later than 60 days prior to an election; and,

WHEREAS, the Maricopa County Elections Department is currently piloting the use of ePollbooks to replace traditional paper signature rosters and precinct registers in future elections.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, AS FOLLOWS:


Section 3. Voting in the Special Election will be on the optical scan system and ballots will be counted on Optech IV-C and III-P Eagles.
