

# Tempe Municipal Court 2018 State of the Court Executive Summary

The 2018 Executive Summary covers my first full year as Presiding Judge. I am proud to report the Court continues to maintain the highest case-to-personnel ratio of the largest municipal courts in Maricopa County while achieving a 99 percent case clearance rate. This has been achieved before a backdrop of significant changes, ranging from personnel to business practices. We hired a new Deputy Court Administrator and the City Council appointed a new City Judge to fill an opening created by an unexpected retirement. We have implemented a Compliance Assistance Program designed to help individuals more easily address their court financial obligations while at the same time restore their driving privileges with the MVD. Our specialty courts for veterans and individuals with a serious mental illness continue to expand to connect participants with appropriate services and treatment to reduce recidivism. Looking forward, the Court will continue to adapt to provide the highest and most efficient level of service and fair justice to all.

- ⇒ Tempe Municipal Court is one of 172 limited jurisdiction courts in Arizona and is the fifth largest Municipal Court in the State in terms of case volume.
  ⇒ The Court has the highest case-to-personnel ratio of the largest Municipal Courts in Maricopa County.
  - The Court has three Judges, two Commissioners and 35 staff.

### » 2017 Operational Efficiencies & Accomplishments «

- Clearance Rate—99 percent, measured as the number of cases disposed compared to filed in FY16/17.
- Established Strategic Agenda to advance the AZ Judicial Branch Strategic Agenda and Tempe City Council Strategic Priorities.
- Collaborated with City Information Technology (IT) staff to meet new AZ Judicial Branch IT Minimum Security standards.
- Created Security and Emergency Preparedness Committee to govern implementation of AZ Court Security Standards.
- Continued to implement AZ Supreme Court Fair Justice for All Task Force recommendations, including creation of a Compliance Assistance Program (CAP) to help people resolve past due fines and fees on certain criminal violations, civil traffic, civil and parking. Assisted 902 people with 960 cases enter into 1,099 CAP time payment contracts 7/2017—3/2018.
- Reprogrammed Case Management System to comply with AZ Supreme Court directive for all courts to replace 1 monthly statistical report with 6 reports to provide more case details.

- Partner with Tempe Kid Zone, History Museum and schools to present annual Law Day program, art contest, and awards.
- Participate in Teen Court's Law Day Celebration, Roosevelt School District.
- Present educational programs on-site and in classrooms.
- Host Tempe Leadership Government Issues Day.
- Awarded \$30,000 Community Development Block Grant (CDBG) to install additional automatic door openers to improve access and exceed ADA requirements.

- Partner with Mercy Maricopa Integrated Care to provide Mental Health Court services to 204 participants in 2017.
- Coordinated The East Valley Regional Veterans' Court and served 504 veterans, including 295 with Tempe cases, in 2017.
  Partner with 6 courts, the U.S. Dept. of Veterans Affairs, Tempe Human Services, Gilbert Youth and Adult Resources, and others.
  Funded in part by the AZ Dept. of Veterans' Services as made available through the AZ Veterans' Donation Fund.

# » Looking Forward «



- Continue to participate in City Facilities Master Plan Project.
