Request approval to abate public nuisance items at the Beck Developments LLC Property located at 1101 W. University Drive. The applicant is the City of Tempe (CM221292).

- Michael Glab, Code Inspector, gave the following overview of this case:
 - Inspector Glab requested a 180-day open abatement for 1101 W University Drive.
 - The case was initiated on 07/26/2022 for a graffiti.
 - Inspector was unable to reach the property owner after numerous attempts.
 - The inspector then presented photos taken earlier in the day showcasing the violations on site.

- Hearing Officer MacDonald approved the 180-day open abatement request found in CM221292.

3. Agenda Item No. 3

Request approval to abate public nuisance items at the Hofstetter Property located at 820 W. Libra Drive. The applicant is the City of Tempe (CE225349).

- Alima Dia, Code Inspector, gave the following overview of this case:
 - Inspector Dia requested a 180-day open abatement for 820 West Libra Drive.
 - The case was initiated on 09/07/2022 for Grass or weeds in gravel landscape.
 - Another complaint had been submitted to the Code Compliance Division
 - A citation was also issued. The property owner did not pay the fee and it was sent to collections.
 - The inspector then presented photos taken earlier in the day showcasing the violations on site.
- Drew Yocom stated no contact has been made by the property owner or any other member of the public to speak on behalf of this case.
- Hearing Officer MacDonald approved the 180-day open abatement request found in CE225349.
