Chair Tapia Introduced Paul Bentley and Kristen Scharlau to the commission. Paul and Kristen then presented the attached PowerPoint and gave an overview of the Care 7 Victim Services.

They then opened the floor for questions or comments. The Commission asked if people residing outside of Tempe can seek the services provided by Care 7. Ms. Scharlau responded yes, Care 7 serves

anyone who seeks assistance. The commission also asked how people can learn about this service. Victims in need of assistance can call 480-350-8004. This number is publicized in many areas across Tempe. Care 7 also has a youth specialist within the high schools, and contact information is provided to students. Additionally, information is available on Tempe's website, and Kris and Paul attend meetings throughout the city to inform people about the Care 7 Victim Services. The HRC asked how they can be of help. Kristen and Paul responded that sharing what they learned tonight with their contacts would be extremely helpful.
