Project Updates by Staff (City Council Action Items)

Ryan Levesque, Deputy Director – Community Development, updated the Commission on City Council items from their March 16, 2023 meeting:

- An introductory and first public hearing was held for IDM Fountainhead. There were some inquiries form the City Council about sustainability elements. The applicant will follow up with those responses.
- An introductory and first public hearing was held for Krispy Kreme/El Pollo Loco. It was well received and there
 were no follow up questions.

The second and final hearing was held for La Victoria Commons. It was approved unanimously with a 7-0 vote.
The City Council was very excited to the see the project move forward and that it was able to integrate into the
neighborhood. Chair DiDomenico asked if the deadline for someone to appeal the approval has passed. Mr.
Levesque advised that there are 30 days for someone to appeal to the Superior Court, which would be April 16,
2023.

Mr. Levesque advised the Commission of two official appeals that were heard by the City Council on previous cases the Commission had voted on:

- A resident of the neighborhood filed an appeal of the DRC's approval of a Use Permit for Stogies. This item will go
 before the City Council at their April 20, 2023 meeting.
- The applicant for Crowne Castle filed an appeal of the DRC's denial of a Use Permit for a cell tower. This item will also go before the City Council at their April 20, 2023 meeting.

Review of future applications with staff

Mr. Levesque provided the Commission with an overview of the items on the agenda for the April 11, 2023, DRC meeting.
