DISTINGUISHING CHARACTERISTICS

This is the entry and training level position in the Utility Services Technician series. This class is distinguished from the Utility Services Technician II+ by the supervised performance of basic, routine plumbing and pipefitting installation and maintenance duties. This is the entry and training level in the Utility Services Technician series. Positions in this classification will acquire needed licenses, Arizona Department of Environmental Quality (ADEQ) certifications, safety training and all related training to become skilled at operating/using small equipment and using/operating hand tools for performing basic/routine plumbing and pipefitting installation and maintenance duties. In this entry level position, the Utility Services Technician I+ will be exposed to the safe operation of heavy equipment as appropriate.

REPORTING RELATIONSHIPS

Receives supervision from the Water Utilities Supervisor or from other supervisory staff.

- Follow safety regulations and safe work practices, including traffic/barricade compliance, proper trenching and shoring procedures and confined space entry procedures.
- Perform preventive maintenance on water distribution, wastewater collection and stormwater infrastructure.
- Assist in completing water service line "hot taps" on water mains; assist in completing sewer service line taps on wastewater mains.
- Assist in the installation, maintenance, repair and replacement of water mains, valves, fire hydrants, water service lines, meters and related appurtenances.
- Assist in the installation, maintenance, repair and replacement of wastewater mains, manholes, cleanouts and related appurtenances.
- Assist in the installation, maintenance, repair and replacement of stormwater mains, catch basins, drains, drywells and related appurtenances.
- Read and interpret the City's Geographic Information System utility maps.
- Open and close work orders by appropriately documenting, reviewing and updating work performed using Tempe's asset management system.
- Respond to and answer customer inquiries.
- Perform related duties as assigned.
