July 5, 2023 Hearing Officer Minutes

#### 2. Agenda Item No. 2

Request approval to abate public nuisance items at the Jannotta Property located at 6606 S. Mitchell Drive. The applicant is the City of Tempe (CE231246).

- Julie Scofield, Senior Code Inspector, gave the following overview of this case:
  - Inspector Scofield requested a 180-day open abatement for 6606 S. Mitchell Drive.
  - The case was initiated on 03/01/23 for deteriorating landscaping.
  - o Two (2) complaints have been submitted to the Code Compliance Division
  - A citation was also issued. The property owner did not pay the fee and it was sent to collections.
  - The inspector then presented photos taken earlier in the day showcasing the violations on site.
- Drew Yocom stated no contact has been made by the property owner or any other member of the public to speak on behalf of this case.

Request approval to abate public nuisance items at the Miles Property located at 702 E. Taylor Street. The applicant is the City of Tempe (CE227562).

  - o Inspector Reyes requested a 180-day open abatement for 702 E. Taylor Street.
  - The case was initiated on 12/19/22 for deteriorating landscaping and dead palm fronds.
  - o A citation was also issued. The property owner did not pay the fee and it was sent to collections.
  - o The inspector then presented photos taken earlier in the day showcasing the violations on site.
- Drew Yocom stated no contact has been made by the property owner or any other member of the public to speak on behalf of this case.

Request approval to abate public nuisance items at the Kalalau LLC Property located at 3239 S. Lebanon Lane. The applicant is the City of Tempe (CE227746).

Request approval to abate public nuisance items at the McCooey Property located at 1430 E. Palmdale Drive. The applicant is the City of Tempe (CE232224).

  - o Inspector Gongora requested a 180- day open abatement for 1430 E. Palmdale Drive.
  - This case was initiated on 4/13/2023 for grass and weeds in the front gravel.
  - A citation was issued. The property owner did not pay the fee and it was sent to collections.
  - The inspector then presented photos taken earlier in the day showcasing the violations on site.
- Drew Yocom stated no contact has been made by the property owner or any other member of the public to speak on behalf of this case.
