DRAFT MEETING MINUTES TAVCO AUGUST 8, 2023

Agenda Item 1 – Call to Order

The chair, Mr. Doiron, calls the meeting to order at 6:30 p.m.

Agenda Item 2 – Public Appearances

The chair asks if there are any individuals online who are there to make a comment. Ms. Fisher informs him that there are none.

Agenda Item 3 – Approval of Meeting Minutes

Mr. Doiron asks if there are any objections/corrections to the minutes of the meeting on August 8. Commissioner Mitnik motions to approve the meeting minutes and Commissioner Lynch seconds. Unanimous approval.

Agenda Item 4 – Aviation History Month Event, Saturday November 18

Mr. Doiron shares that he found an article from an author who is a contributor to the Tempe Historical Society about an interesting article that he found. The Chair states that he recalls wanting to get another meeting with Commissioners and Museum staff together. Fisher stated that she did not attend that meeting and needed to know what follow up was needed. Fisher also stated that she recently reached out to Museum staff about this event and they will be providing her with some of there findings. Commissioner Mitnik asked about what format the information is going to be on, both with logos/style and material (poster, brochure, flyer). Fisher reviews the memo that was attached in the agenda package as three buckets of information

including: 1) Tempe History Museum photos on posters, 2) Aircraft Noise and TAVCO information on brochures/flyers/poster, and 3) Flight procedure and IGA in a PowerPoint.

Chair mentions that he has a copy of the original IGA and Fisher states she will scan and send out.

Agenda Item 6 – Tempe City Council Correspondence

Chair reminds Commissioners that the past discussion has been about wanting more engagement with Mayor and Council. Fisher adds TAVCO discussed several ways of going about engaging with Mayor and Council, and this discussion was taking place prior to the vote regarding the coyotes' proposal. Discussion included having Commissioner McBride drafting a letter and included TAVCO participating in the Board and Commission presentation that was going to Council at a Council Meeting. Fisher stated she has not reached out to any Councilmembers at this time to wait for further direction from the Commission. The Chair asked Commissioner McBride if he could draft a letter for review.

Commissioner Mitnik stated that he was disappointed in the presentation and the report. Commission McBride stated that he attended that Council meeting in person and did not feel like it addressed any concerns in depth. Fisher states that she can commit to continue to work with the consultants and staff and keep TAVCO members as updated as possible and will bring the consultants to TAVCO when given the chance.

Agenda Item 8 - Commissioners' Business

Chair asks for an update on the requested Sky Harbor tower tour. Fisher states she reached out and reports that staff asked to push out to fall for better email.

Commissioner Mitnik asks about an update on the solution to tracking and monitoring data. Fisher states that Tempe is still working with consultants to meet some tracking and monitoring needs but that these needs also relate to litigation. Fisher explains that the consultants are assisting the city in looking at data that could help with the claim to reduce the 65DNL. Commissioner Mitnik states that there is so much importance in having the flight data saved for historical and legal purposes. Questions are raised about data storage for noise monitoring and flights.

The meeting is adjourned at 7:04 p.m.


