

#### **PURPOSE:**

The purpose of this memo is to provide the Commission with an update of the second round of public comments for the Kyrene, Roosevelt, Farmer Bike/Ped Improvements Project which is proposing to connect the Western Canal Path at Kiwanis Park, to University Drive in downtown Tempe. Prior to holding the 2<sup>nd</sup> round of public meetings, staff received requests to meet with Dwight Park neighborhood residents to discuss their concerns with the proposed alignment of the project going through Dwight Park. Following this meeting with residents, a second alternative was developed for consideration which provided an alternate route along adjacent streets, rather than through Dwight Park. Staff then presented both alternatives during the public meetings held September 20<sup>th</sup>, 2023 and included the two alternatives within the survey to better understand the neighborhood's preference and solicit specific feedback for each option.

This update will include a review of the 60% plan survey results from the second round of public surveys completed between September 20th and October 10th, 2023, with a focus on the feedback related to the two alternatives to either provide a Multi-use path through Dwight park or shared-lane marking on the surrounding streets. Based on the responses and feedback from ~100 survey results, 85% of all survey respondents, and 60% of Dwight Park residents preferred the originally proposed path alternative through Dwight Park. After reviewing the feedback, the project will continue to pursue the route utilizing a Multi-use path through Dwight Park

#### **BACKGROUND INFORMATION:**

This Transportation Master Plan identified project kicked-off its final design in October 2022. The first round of public meetings were held April 19th, 2023 on the draft 30% designs for the project. Staff worked with the consultant to integrate comments from the public into the draft 60% design plans, which were completed in July of 2023. A second round of public meetings were held September 20th to review the draft 60% designs. The public survey was available for comment from September 20th to October 10th, 2023.

Staff is now working with the design team to incorporate the feedback received from the 2<sup>nd</sup> round of public meetings. It is anticipated that the final design will be completed summer 2024, with construction beginning early 2025.









## **Second Round of Public Feedback**




The survey was available online from 0ct. 4-10

101 respondents provided an address with approximately 99% in Tempe.

#### Themes:

- Overwhelming preference for Dwight Park MUP and not sharrows
- One or two additional Orbit stops on Roosevelt (13<sup>th</sup> St Broadway Rd)
- More Physical Barriers and addition of vertical delineators
- Positive reaction to addition of Baseline North Side -Western Canal Connection



- Alternative 1: Dwight Park 10ft wide multiuse path - protects in place all existing trees, provides new trees, and lighting
- Alternative 2: Sharedlane markings (Sharrows) continuing along La Jolla Drive and Wilson Street



**PURPOSE:** To provide the Commission with information regarding the status of our planned roundabout at the intersection of College and McKellips, and updates to our existing roundabout at Priest and Grove.

#### RECOMMENDATION OR DIRECTION REQUESTED:

This item is for informational purposes only.

#### **CITY COUNCIL STRATEGIC PRIORITY:**

- 3.27 Traffic Delay Reduction: Achieve a Travel Time Index average at or below 1.25 along major streets during rush hour traffic with no individual segments exceeding 2.0
- 1.08 High Severity Traffic Crashes: Achieve a reduction in the number of fatal and serious injury crashes to zero

#### BACKGROUND INFORMATION:

Roundabouts are one strategy that can be applied at an intersection. In many cases, they reduce congestion and have been shown to reduce the occurrence of serious and fatal injury crashes. Tempe currently has two functioning roundabouts, and one which has been planned and designed, but not constructed.

Prior to the pandemic, a roundabout was designed through the final design phase for the intersection of College and McKellips. However, due to the pandemic and resulting fiscal uncertainty, the roundabout was never built. At this time, the city is in the process of reviving that design for construction. The current timeline anticipates construction to begin in Spring 2025.

One of the existing functioning roundabouts in the city is located at Priest and Grove. This roundabout was constructed in Summer 2021. In the past year, the police department identified a pattern of crashes occurring in the vicinity of the roundabout. As a result, traffic engineering and street maintenance is working to update some elements of the roundabout to enhance visibility and awareness.







# **Priest Drive & Grove Parkway**


- Previously a one-way stop, T intersection, now a 2-lane roundabout

# **Priest Dr. & Grove Pkwy**


- PD recently noticed a pattern in crashes at the roundabout in 2023


