SUBJECT: Government Relations Update

Below you will find the latest update on the current Arizona legislative session, actions taken by the governor to sign or veto bills, and federal policies. This memo also contains links to the legislature's webpage where you can find the background, status materials, and bill texts/summaries.

State Legislature

The legislature met throughout the week after the Legislature and the Governor secured a budget deal Tuesday. The House and Senate have debated bills covering water policy, election policy, sober living homes, and other critical issues. The Legislature is debating the budget and other bills at the time of writing. A complete list of bills passed—along with a fuller analysis of the proposed budget (which may pass as early as Friday night)—will come with next week's legislative update.

Below are some highlights of the proposed budget deal (HB2897-HB2911; SB1735-SB1749). A short analysis of the impact of key provisions on cities, developed by staff from the League of Arizona Cities and Towns, is attached to this document.

- \$16.1 billion for FY2025, a decrease from \$17.2 billion in FY2024
- Budget deficit projected to be \$1.4 billion (\$729 million for FY2024; \$690 million for FY2025)
- \$333 million cut to the Water Infrastructure Finance Authority (eliminates a third year of funding for previously approved projects)
- \$97 million cut to Long-Term Water Augmentation Fund
- \$11 million cut to ASU
- \$108 million in ADOT funds for I-10 widening moved to FY2026
- The Departments of Child Safety, Public Safety, and Corrections were exempt from the average 3.5% cut most state agencies are subject to

The Legislature acted on the following key bill for cities as of Thursday night:

HOUSE

Committee of the Whole

SB1361 – sober living homes (Do Pass as Amended recommendation; will be heard under third reading on 6/14)

Provides a comprehensive definition of a sober living home, ensuring any operator purporting to provide housing for those receiving services be licensed and regulated by the AZ Department of Human Services. Facilities must comply with local zoning/building/fire codes to receive or renew a license. Mandates regular on-site inspections of sober living homes increases civil penalty for non-compliance from \$500 to \$1,000 for each violation, and requires ADHS to deny a license application, suspend a license, or revoke a license for non-compliance.

Third Reading

SB1677 – firefighters; peace officers; PTSD; therapy (Passed, 54-5-1)

Conditionally upon the U.S. Food and Drug Administration (FDA) approval of midomafetamine, or MDMA, for treatment of post-traumatic stress disorder (PTSD) by December 31, 2025, authorizes workers' compensation coverage to include one complete course of MDMA treatment for firefighters



and certified peace officers diagnosed with PTSD, if certain requirements are met. Prescribes treatment stipulations and reporting requirements.

SCR1023 – general election day; all offices (Passed, 31-29)

Subject to voter approval, constitutionally requires that a general election for city, town and school district officials must take place on the first Tuesday after the first Monday in November of every even numbered year.

SENATE

Third Reading

HB2481 – open meetings; public body; legislature (Failed, 13-14-3)

Expands open meeting law requirements to apply to all public bodies, except the Legislature, and requires all public bodies to provide for an opportunity for public comment before any final decision. Requires a public meeting agenda to be available at least 48 hours before the meeting.

HB2632 – state agencies; powers; continuations (Failed, 12-15-3)

Continues, retroactive to July 1, 2024, the ADOA, OSHA Review Board, Boiler Advisory Board, AZBTR, ASPB, GOTR, Arizona Historical Society and the Prescott Historical Society until July 1, 2026.

HB2742 – aggravated assault; transit; airport; rail (Passed, 23-4-3)

Adds public transit employees, airport employees and railway workers as protected persons in the aggravated assault criminal classification.

HJR2001 – Phoenix-Mesa Gateway Airport; reuse zone (Passed, 21-6-3)

Continues the designation of the Phoenix-Mesa Gateway Airport as a Military Reuse Zone through October 19, 2031.

HB2274 – theme park districts; formation (Passed, 19-7-4)

Decreases, from 1,000,000 persons to 500,000 persons, the population threshold for the governing body of a city to establish a district in conjunction with a county with a population of more than 125,000 persons.

HB2719 – bond elections; date; voter turnout (Passed, 16-10-4)

Consolidates local bond elections to occur only in even numbered years and requires a majority vote of at least 60 percent to create an indebtedness or issue bonds. Increases the threshold from 15% to 25% to order a bond election.

Final Reading

SB1370 – youth businesses; licenses; tax; exemption (Passed, 16-10-4)

Prohibits a municipality or county from requiring a license or permit for a business that operates occasionally by a person under 19 years of age. Creates a transaction privilege tax (TPT) exemption.

SB1677 – firefighters; peace officers; PTSD; therapy (Failed, 15-9-6)

Conditionally upon the U.S. Food and Drug Administration (FDA) approval of midomafetamine, or MDMA, for treatment of post-traumatic stress disorder (PTSD) by December 31, 2025, authorizes workers' compensation coverage to include one complete course of MDMA treatment for firefighters and certified peace officers diagnosed with PTSD, if certain requirements are met. Prescribes treatment stipulations and reporting requirements.

SCR1023 – general election day; all offices (Failed, 14-12-4)

Subject to voter approval, constitutionally requires that a general election for city, town and school district officials must take place on the first Tuesday after the first Monday in November of every even numbered year.

Federal Update

Congress

This week, the U.S. House voted to hold Attorney General Merrick Garland in contempt of Congress for allegedly ignoring subpoenas from the Judiciary and Oversight/Accountability Committees. The Attorney General submitted transcripts of President Biden's interview with Special Counsel. The House Committees subpoenaed the audiotapes of the conversation, which the President withheld under executive privilege. It is extremely unlikely the U.S. Department of Justice will hold the Attorney General in contempt.

The House also passed the annual <u>National Defense Authorization Act</u>, which includes a 19.5 percent pay increase to junior enlisted personnel, funding for troop housing, and provisions to end affirmative action at service academies and deploy the National Guard to the southern border.

The U.S. Senate <u>tried and failed</u> to pass legislation to make access to IVF a protected right under federal law, confirmed a judge to the District of Columbia Superior Court and approved nominees for the Federal Energy Regulatory Commission.

Administration

- On June 12, President Biden <u>submitted</u> to the U.S. Senate his 51st list of judicial nominees, bringing the total number of federal judicial nominees during his administration to 247.
- On June 13, President Biden <u>announced</u> nominees for ambassadorships (Cameroon, Bahrain, and Kyrgyzstan) and various boards.
- On Friday, the leaders of the G7 nations issued a statement announcing:
 - \$50 billion in frozen Russian assets would be used to finance military and humanitarian aid to Ukraine
 - Commitments on climate and energy (including a phaseout of unabated coal power generation by the first half of the 2030s)
 - The need for a ceasefire and long-term solution in Gaza
 - Efforts to reduce the debt burden on developing countries, empowering the International Monetary Fund, and public-private partnerships to invest in developing nations through the Partnership for Global Infrastructure and Investment

Budget Bills

SB1735/HB2897 general appropriations act; 2024-2025

- Appropriates \$12.2M to the Department of Emergency & Military Affairs and \$5.0M to the Department of Public Safety for local border support
- Repeals the \$333M appropriated to WIFA for FY 2025
- Appropriates \$217,700 to the Seriously Mentally Ill Housing Trust Fund
- Appropriates \$3M to the Department of Emergency & Military Affairs to assist law enforcement fentanyl interdiction
- Appropriates \$1M to DHS for fentanyl overdose medication distribution
- Appropriates \$371,000 to the Housing Trust Fund
- Appropriates \$84,700 in municipal firefighter reimbursement administration
- Appropriates \$1.4M to the Department of Financial Institutions for local grants to combat automobile theft
- Appropriates \$2.0M to the Department of Revenue for 25 new FTE positions for additional audit and collections staff.
- Rescinds \$23.6M in FY 2024 for rural broadband matching funds

SB1736/HB2898 amusements; 2024-2025

SB1737/HB 2899 capital outlay; appropriations; 2024-2025

- Appropriates \$25,550,000 from the State Aviation Fund for municipal airport construction and improvements
- Section 8 delays a combined \$49M appropriation made in FY 2021 and FY 2023 to FY 2028 for the SR347/Riggs Rd overpass
- Section 9 delays a combined \$108M appropriation made in FY 2023 and 2024 for I-10 lane expansion in the West Valley to FY 2028
- Section 10 diverts an appropriation of \$29,343,200 from the State Highway
 Fund made in FY 2023 for road rehabilitation to the state GF
- Cuts \$10M in FY 2024 for improvements to SR97
- Cuts \$41M in FY 2024 to ADOT for pavement rehabilitation
- Sweeps \$38,237,100 from State Parks Rev Fund to the state GF in FY 2024
- Sections 14 through 22 reduce transportation funding to specified projects authorized in FY 2023 and FY 2024
- Sections 23 through 28 provide supplemental appropriations for various transportation projects

- Section 29 sweeps \$9M from State Highway Fund to the state GF in FY 2024
- Section 32 requires distribution of \$87.5M to the Town of Queen Creek originally appropriated to ADOT in FY 2024 by the end of FY 2024

SB1738/HB 2900 commerce; 2024-2025

Repeals the Rural Broadband Accelerated Match Fund

SB1739/HB 2901 criminal justice; 2024-2025

SB1740/HB 2902 environment; 2024-2025

SB1741/HB 2903 health care; 2024-2025

SB1742/HB 2904 high education; 2024-2025

SB1743/HB 2905 human services; 2024-2025

 Repeals the Homeless Shelter and Services Fund in FY 2026 and transfers unexpended monies to the state GF.

SB1744/HB 2906 K-12 education; 2024-2025

No impact to cities

SB1745/HB2907 local government; 2024-2025

No impact to cities

SB1746/HB 2908 state buildings; management; 2024-2025

No impact to cities

SB1747/HB 2909 taxation; 2024-2025

- Section 1 delays the implementation of HB2382 (TPT; sourcing; validation) until 2028, pushing back the requirement for the DOR to create a process for 3rd party service providers to identify TPT sourcing by 2 years.
- Sections 2 and 3 extend the TPT and Use tax exemptions for qualifying equipment related to healthy forest projects through December 31, 2026.

- Section 8 addresses the *Qasimyar* refund issue for cities, towns, and counties. If a taxing jurisdiction estimates the judgment will result in an increase of 4% or more from its 2023 property tax rate, it may:
 - Issue tax anticipation notes that mature on or before July 31 four fiscal years after the issuance of the notes, or
 - Request that state loan commissioners issue state bonds to redeem or refund tax anticipation notes, which the taxing jurisdiction shall be responsible for reimbursing to the state treasury.

This is intended to allow local jurisdictions the opportunity to spread out the cost of *Qasimyar* refunds coming due during FY 2025.

Section 10 addresses the FY 2025 assessment for the DOR's new tax system.
The local jurisdiction assessment is approximately \$6.6M, of which, cities
and towns are responsible for about \$4.7M, a total increase of roughly \$20K
compared to the FY 2024 assessment.
