SUBJECT: Homeless Outreach Prevention Effort (HOPE) Team Schedule Change



PURPOSE:

The purpose of this memorandum is to provide an update to Mayor and Council regarding upcoming changes to Tempe's Homeless Outreach Prevention Effort (HOPE) team member deployment schedule based on detailed analysis of HOPE street outreach service requests, to better allocate resources to meet the needs of our community.

CITY COUNCIL STRATEGIC PRIORITY:

Quality of Life – 3.28: Achieve an end to homelessness in Tempe as measured by Tempe's annual count.

BACKGROUND INFORMATION:


In August 2022, the City of Tempe's street outreach team, HOPE, was shifted from a daytime only service model, to providing service 24 hours a day, seven days per week. That same month, the CARE & HOPE Line, 480-350-8004, was established and calls for service were received and dispatched, in addition to requests for services from HOPE via email at HOPE@tempe.gov.


In Fiscal Year 2022/23, the City of Tempe received funding from an Arizona Department of Housing (ADOH) Homeless Shelter and Services Notice of Funding Availability (NOFA) grant for two HOPE team members. This funding expired on June 30, 2024, reducing the number of HOPE team members from fifteen to thirteen. In consideration of the current 24-hour schedule; this reduction in staffing reduces the number of proactive and responsive outreach engagements during daytime hours by a total of 80 hours per week.

DATA ANALYSIS:

The City of Tempe Information Technology Department provided a 90-day sample of requests for service from December 9, 2023, to March 7, 2024. In total, there were 797 requests for service. This number includes all service requests placed via the CARE & HOPE Line, and the HOPE@tempe.gov email address.

The following infographics demonstrate significant gaps in service requests from 10 p.m. to 6 a.m., and further demonstrate the need to update shift schedules to appropriately deploy HOPE resources in accordance with Tempe's commitment to making homelessness a rare, brief, and one-time experience in the community.





Of the 797 requests for service, a total of 10, or 1.3% of all requests, were received between the hours of midnight (12 AM), and 7 AM. Upon further review, when expanding the timeframe to reflect the service hours of 10 PM to 7 AM, a total of 26 requests, or 3.3% of all service requests received, were made. These trends remained consistent on a weekly basis throughout the 90-day data set.

Analysis shows a noticeable, and significant reduction in requests for service during the hours when most community members, both housed and unhoused, are asleep. Within the data set, 29% (233/797) of HOPE requests for service occur between 9 AM and noon (12 PM), while 67% (533/797) of HOPE requests occur, daily, within the six-hour timeframe of 9 AM to 3 PM.

SCHEDULE CHANGES:

The schedule matrix below will be released for shift bid on August 12, 2024. This schedule reallocates HOPE team members from the midnight to 6 AM shift when a total of 10 requests for service over a 90-day period were made, to the higher demand times for service between 9 AM and 3 PM. This schedule was approved by the Community Health and Human Services Director, and the steps for further review and approval consideration by Tempe's non-supervisory United Arizona Employee Association (UAEA) Union have been initiated.

With the staffing of Tempe's shelters being 24 hours per day, a system has been established for when a CARE 7 or a Tempe Fire Medical Rescue First Responder require immediate space for shelter placement. Moving forward, this protocol will continue to allow for the adjustment of the HOPE schedule to meet the needs of the community during high-volume service request times.

In addition, this schedule adjustment supports ongoing initiatives impacted by the reduction of staffing due to the expiration of grant funds. This includes proactive outreach between requests for service, scheduled daily office hours and drop-in times at Tempe Public Library, and staffing safety as it relates to the ability to dispatch HOPE in two-person teams.

SUBJECT: 2024 Comparative Cost of Services Report


Each year the Municipal Budget Office performs an analysis of the estimated annual amounts paid by the typical residential Tempe household for direct services provided by the City of Tempe as well as the estimated total annual amount paid in City of Tempe property and transaction privilege (sales) taxes. These amounts are then compared to the estimated annual amounts paid by the same typical residential household in seven comparison cities in the Phoenix metropolitan area.

For purposes of this comparison, we utilized the property tax, sales tax, and utility service rates as of July 2024. The analysis assumed the same household consumption amounts for all cities for both water and wastewater services. However, for property tax purposes, we utilized the median single-family home value in each respective city in the analysis. The sales tax amounts are based on the Phoenix metropolitan area median household income. As such, this analysis is intended to reflect what the typical residential household would pay for each of the services or pay in taxes in their respective city.

Average annual household cost for property tax, sales tax, water, wastewater, and solid waste services


Estimated Annual Cost





Solid Waste

The annual amount for single family residential solid waste services is estimated at \$382 for the City of Tempe. The amounts noted are based on a residential customer with a once per week collection, based on the rates as of July 2024.



Water and Wastewater

The annual total amount for water and wastewater services for a single-family residential customer in the City of Tempe is estimated at \$872. The annual water charge is based on a typical single family residential monthly water consumption of 10,000 gallons, consistent with the most recent water rate study. It is assumed that this water consumption amount is applicable to the other cities in the comparison. As such, this consumption amount was applied to each respective city's water rates as of July 2024 to derive the annual water costs.

The billable gallons of wastewater are derived from a typical residential three-month winter average water 10,000 consumption of gallons (January - March billing statements), and then multiplied by a rate of return. For example, Tempe's rate of return is When multiplied by 10,000 70%. gallons, the result is 7,000 billable wastewater gallons per month. It is assumed that the typical water consumption is applicable to the other cities. As such, this consumption was applied to each respective city's rate of return as of July 2024 to derive the annual wastewater costs.




City Sales Tax

The annual amount that the typical

Tempe residential household will pay in City of Tempe sales tax is estimated to be \$782 for 2024.


For this analysis, we utilized the Phoenix metropolitan area median household income of \$75,969 per the U.S. Census Bureau, American Community Survey. As median incomes can vary between the cities, the Phoenix metropolitan area median household income was utilized so that a direct comparison could be made between cities. The portion of this income that was spent on taxable purchases is estimated at 57% (\$43,460), as noted in the latest Consumer Expenditure Survey published by the U.S. Bureau of Labor Statistics (September 2023). We assumed that the portion of the median income spent on taxable purchases was spent within the household's city of residence and applied to each city's applicable sales tax rate.

Please note that many of the comparison cities in the analysis utilize different tax rates for various taxable activities. For example, the City of Glendale has an overall sales tax rate of 2.9%; however, sales at restaurants and bars are taxed at 3.9%. These variances were considered when calculating the annual amount of sales taxes paid.



City Property Taxes

The annual estimated City of Tempe property tax amount is \$469. The property tax amounts shown are based on each city's FY 2024-25 primary and secondary rates and each city's 2024 Limited Property Value (LPV) for the median single-family home.



The 2024 median single family LPV for each city, per the Maricopa County Assessor, is as follows:

It should be noted that the City of Mesa and the Town of Gilbert only levy a Secondary Property Tax.
