Study Purpose & Need

- Reduce traffic congestion
- Improve traffic flow through the study corridor
- Reduce crashes
- Accommodate pedestrian and bicycle traffic, safety and connectivity concerns
- Develop design alternatives and recommend an alternative for final design





Study Process

Completed Steps:

- Public and agency scoping process
- Data collection and traffic modeling

Current/Upcoming Steps:

- Obtain public input
- Identify preferred alternative and prepare final Design Concept Report (DCR) and environmental documents
- Develop and refine prefered alternative
 - Engineering design and environmental analysis
 - Right-of-way and cost estimates

No Build Scenario

- No improvements to the existing interchange or to Baseline Road
- Existing roadways and traffic signals remain unaltered



Modified Diamond Interchange (MDI) Alternative

- Keeps the interchange and ramp configuration as they are
- Adds right turn lanes on Baseline Road and I-10 on- and off-ramps to improve traffic operations




Modified Diamond Interchange (MDI) Alternative



Diverging Diamond Interchange (DDI) Alternative

- Converts the interchange into a new configuration
- Allows through and left-turning traffic to proceed simultaneously





Diverging Diamond Interchange (DDI) Alternative



Modified Diamond Interchange (MDI) Alternative Pros & Cons

Pros

- Driver and pedestrian familiarity
- Improves bicycle and pedestrian facilities
- Improves safety by reducing conflict points
- Fewer impacts to existing facilities (.45 acres of right of way)
- Least expensive (Estimated cost of \$16.1 million)

Cons

- Fewer benefits to traffic operations and safety
- Change in some business access from Baseline Road



Diverging Diamond Interchange (DDI) Alternative Pros & Cons

Pros

- Improved traffic operations and safety
- Reduces conflict points between traffic
- Signal operation further decreases travel time

Cons

- More impacts to existing facilities (2.29 acres of right of way)
- Requires bicyclists and pedestrians to cross into median
- Challenges to I-10 incident management
- Most expensive of the build alternatives (Estimated cost of \$40.8 million)

PURPOSE:

The purpose of this memo is to provide the Commission with a review of four preliminary design alternatives for a grade separated crossing at College Avenue and University Drive.

RECOMMENDATION OR DIRECTION REQUESTED:

BACKGROUND INFORMATION:

The College and University Grade Separated Crossing Project was first initiated as part of an ASU commissioned study that the City of Tempe participated in to explore grade separation at three high pedestrian volume intersections. The goal of the study was to provide a dedicated pedestrian crossing to address pedestrian/vehicular conflicts and reduce transit/vehicular congestion. After the study was complete in 2020, the City of Tempe pursued and were ultimately awarded federal grants to complete the final design and construction of the highest pedestrian volume intersection: College Ave and University Dr.

In December 2023, Bowman Group was selected to prepare the final plans, specifications, and estimate for the project. In May 2024, the project's design kicked-off. After data collection and receiving preliminary feedback from the directly adjacent property owners (ASU and Newman Center), four preliminary design alternatives have been developed that we are seeking feedback on:

1: Pedestrian Bridge

- 2A: Underpass on the West side of College Avenue
- 2B: Underpass in a SW/NE alignment
- 3: "Y" Underpass, providing entrances on both the northwest and northeast corners

Throughout September, staff will be seeking feedback from the Commission on Disability Concerns, Transportation Commission, Historic Preservation Commission, and City Council. Two broader public meetings are also anticipated to take place in late October. Additional outreach will be taking place from late 2024 through summer 2025 at the draft 30% and 60% design stages.

- Started in 2019 as part of an ASU commissioned study of grade separating three high pedestrian volume intersections.
- In 2022, the City applied for and were awarded federal grants to complete this project's final design and construction
- Project's design kicked-off in May 2024, with utility research, data collection, and stakeholder's meetings with the immediately adjacent property owners.




Stakeholder Feedback Tempe Themes

Newman Center:

- Maintain clear access to alley, College Ave entrance, College Ave staircase, HVAC equipment.
- Protect in place architectural features and elements of the church, with special consideration to construction impacts such as vibrations.
- Maintain visibility of Mary College and Newman Community Center

ASU:

- Protect in place and maintain clear visibility of landmark signage
- Ensure proposed bridge landings and/or underpass ramps are placed west of Cady Mall and Alumni Lawn
- Provide access for golf carts to circulate around improvements




