# Agenda Item 4 – Review and Approval of July 16, 2024 Minutes

#### Agenda Item 5 - Chair Remarks

Chair Oliver welcomed Councilmember Hodge and thanked the Councilmember for her presence.

Chair Oliver noted that Director Tim Burch was absent from the meeting due to unforeseen circumstances.

Chair Oliver advised that the Commission would discuss the strategic plan for the upcoming year.

# <u>Agenda Item 6 – Community Health and Human Services Department Update – Director Tim Burch</u>

Agenda Item was deferred due to Mr. Burch's absence.

Ms. Galvan advised that the search for a new Deputy Director of Social Services is ongoing and interviews were being conducted.

#### Agenda Item 7 - Family Justice Commissioner Introduction - Commission Member Baines

Commissioner Baines advised that his nonprofit is called Fulfillment In Training (FIT) and they utilize fitness as the bonding tool that gets people motivated to improve health, education, emotional wellbeing, mental health, and financial literacy. Commissioner Baines mentioned FIT's afterschool program, which provides tutoring and works with families to ensure children's grades are kept up, provides monthly field trips, and teaches children how to use public transportation to attend events and activities they would not normally have the ability to take part in.

Commissioner Baines mentioned that he started FIT after working in social services and identified that parents were often at risk of losing housing due to the behavior of their children.

Commissioner Baines noted that FIT identifies root causes of disruptive or antisocial behavior and then works towards positive outcomes by dismantling barriers to kids being productive members of society.

Commissioner Baines advised that FIT often brings in trades people to do demonstrations and teach various trades to connect and prepare children to establish solid career pathways.

Commissioner Baines mentioned that the mission of FIT is to inspire, encourage, and activate children to achieve and to create equity in communities by inspiring people to be the best version of themselves.

#### Agenda Item 8 – Introduction to the Arizona Coalition to End Sexual and Domestic Violence – Sierra Mark

Ms. Mark introduced herself and gave an overview of the Arizona Coalition to End Sexual and Domestic Violence.

Ms. Mark advised that each state has a coalition and their mission is to provide support and training to providers of services to victims of sexual assault and domestic violence.

Ms. Mark advised that the coalition also hosts a legislative advocacy day annually to lobby for policy and legislation.

Ms. Mark mentioned the sexual assault reimbursement program, which can cover the cost of medical care needed as a result of victimization – on the conditions that the assault occurred in Arizona on or after January 1, 2022, the victim received a forensic exam, the victim provided a release of information, and the victim received acute treatment within 30 days of the assault.

Ms. Mark noted that victim does not need to report an assault to law enforcement to receive compensation.

Ms. Mark mentioned that the coalition also provides survivor engagement opportunities, including a speaker's bureau that works to help survivors who wish to advocate by telling their story to media.

Ms. Mark noted that the organization is primarily grant funded and includes approximately 30 staff members in Arizona.

Commissioner Davis advised that her concerns were reported to the City and have since been addressed.
