Agenda Item 2 – Discussion about nuisance issues in neighborhoods

Discussion began with the background for developing a nuisance ordinance based on a similar ordinance in Anchorage, Alaska. It was an outcome of illegal sober living home issues in neighborhoods and how to support community safety. The problem to be solved with this proposed ordinance is to reduce negative incidents at properties and the burden that excessive calls for service have on limited resources. This gap in enforcement limits the Police's ability to manage repeat disturbances, which can strain resources and negatively impact the surrounding community. Developing more robust mechanism to address these recurring issues would improve both public safety and overall quality of life for affected neighborhoods.

The new ordinance would be applied broadly to specific types of calls to a property within a calendar year. It would establish clear definitions for validated call types and set a threshold for the number of calls allowed each month. Certain exclusions would apply, such as domestic

violence, which would not be counted toward the threshold. The subcommittee would need to work to further define the validate call types.

Agenda Item 3 – Ordinance policy development and timeline

Community Development staff highlighted the significant value of the nuisance ordinance in reducing habitual code violators and noted its success in working collaboratively with the Police Department. Vice Mayor Garlid's Office will coordinate research and draft an ordinance with Community Development, Fire, Police and the City Attorney's Office. City Attorney will form an ordinance committee for review.

Two public meetings will be held to present the ordinance to the community before it is returned to the Committee of the Whole for final review and subsequent City Council action.
