- Nancy Goren, Tempe Municipal Arts Commission (TMAC) Chair, welcomed representatives from Arizona Academy of Performing Arts and Childsplay.
- Dr. Glenn Waterkotte, Arizona Academy of Performing Arts Board Member, presented information related to Arizona Academy of Performing Arts' operations, programs and impact on the Tempe community during fiscal year 2011-2012.
- Steve Martin, Childsplay, Inc. Managing Director, presented information related to Childsplay's operations, programs and impact on the Tempe community during fiscal year 2011-2012.

Agenda Item 3 - Grants Committee

- Maja Aurora reminded the Tempe Municipal Arts Commission (TMAC) members that the
 Art Grants Panel Review for fiscal year 2012 2013 took place on May 25; Aurora
 further reported that the panel reviewed 14 art project grant applications.
- M. Aurora thanked the TMAC members for their meeting attendance and described the
 arts grant application panel review process, as well as the role of the TMAC's award
 recommendations being forwarded to the Tempe City Council for review and approval.
- M. Aurora further presented the Arts Grants Review Panel's award recommendations;
 M. Aurora stated that the recommendation values for the arts project grants were calculated using the median value of each grant established by five voting members of the 2012 2013 Arts Grants Review Panel.
- TMAC members recommended the funding of 13 arts grants, 11 arts project grants and 2 organizational development grants.
- TMAC members recommended three arts project grants be denied funding as the applications did not meet Tempe-specific criteria outlined within the City of Tempe Arts Project Grant application material.

applications for the fiscal year 2012 - 2013.
