#### Agenda Item 3 – General Plan 2040 Update

- Nancy Ryan, Project Manager Coordinator for Community Development and Planning, presented information about City of Tempe General Plan 2040. Discussion highlights included:
  - -The City of Tempe General Plan 2040 is the guide to growth and development of services in the City over the next 30 years, and it must be reviewed every 10 years.
  - -First public meeting regarding the General Plan was on September 24<sup>th</sup>, 2012, and the next meeting will be held on Tuesday, January 22<sup>nd</sup>, 2013 at the Tempe History Museum, 809 E Southern Avenue, Tempe AZ 85282.
  - -Tempe Municipal Arts Commission (TMAC) members were encouraged to attend meetings regarding the General Plan.
  - -TMAC members were encouraged to apply to be a part of the Community Working Group, a panel of 15 citizens charged with developing goals, policies, and strategies for the General Plan. Applications for the Community Working Group are due on October 15<sup>th</sup>, 2012.

#### Agenda Item 4 - Discussion of TMAC Goals for Fiscal Year 2013-2014

- Maja Aurora, Arts Coordinator Grants; Public Art/Art in Private Development, and Barbara Roberts, Deputy Director - Library and Cultural Services Division, facilitated discussion of the Tempe Municipal Arts Commission (TMAC) goals based on the existing City Ordinance. Discussion highlights included:
  - -A need to develop a Municipal Arts Plan for 2013 using the Municipal Arts Fund budget and previous TMAC strategic plans as a guide.
  - -TMAC members agreed to individually create up to five goals for each of the following categories: 1) Grants; 2) Advocacy and Communication; 3) Public Art; 4) Art in Private Development; and 5) Facilities
  - -M. Aurora will compile these goals to be distributed to each of the TMAC members before the next meeting in order to facilitate further discussion.
  - -TMAC members agreed to hold another special meeting on this topic on a date and time that is to be determined.
