**CERTIFICATE OF THE MAYOR AND COUNCIL OF THE CITY OF TEMPE, ARIZONA,
RELATIVE TO THE SPECIAL BOND ELECTION HELD ON MARCH 11, 1997.**

The Mayor and Council of the City of Tempe, Arizona, hereby certify as follows:

1. Pursuant to the resolution passed and adopted by the Mayor and Council on January 9, 1997, an election was duly and regularly held on March 11, 1997, for the purpose of approving the issuance and sale of bonds in the total principal amount of \$90,000,000 to provide funds to make various municipal improvements.

2. The election has been conducted and the official returns thereof have been filed as required by law and that the total number of votes cast at the special bond election in answer to the question submitted were as follows:

The tabulated votes for each specified bond question is set forth in the attached final cumulative report.

3. Each and every person who voted at the special bond election was a qualified elector of the City of Tempe; proof of the due and regular publication of the Notice of Special Bond Election has been made and filed with the Mayor and Council and placed upon the minutes of the Council.

4. The majority of the votes cast at the election was in favor of this Council incurring indebtedness of the City in the total authorized principal amount of \$90,000,000 by the issuance and sale of all of the bonds described in all of the questions. The Mayor and Council hereby order the issuance and sale of all the bonds of this issue.

IN WITNESS WHEREOF, the Mayor and members of this Council have hereunto placed their hands and caused the same to be attested by the Clerk and the seal of the City of Tempe to be affixed hereto on March 20, 1997.

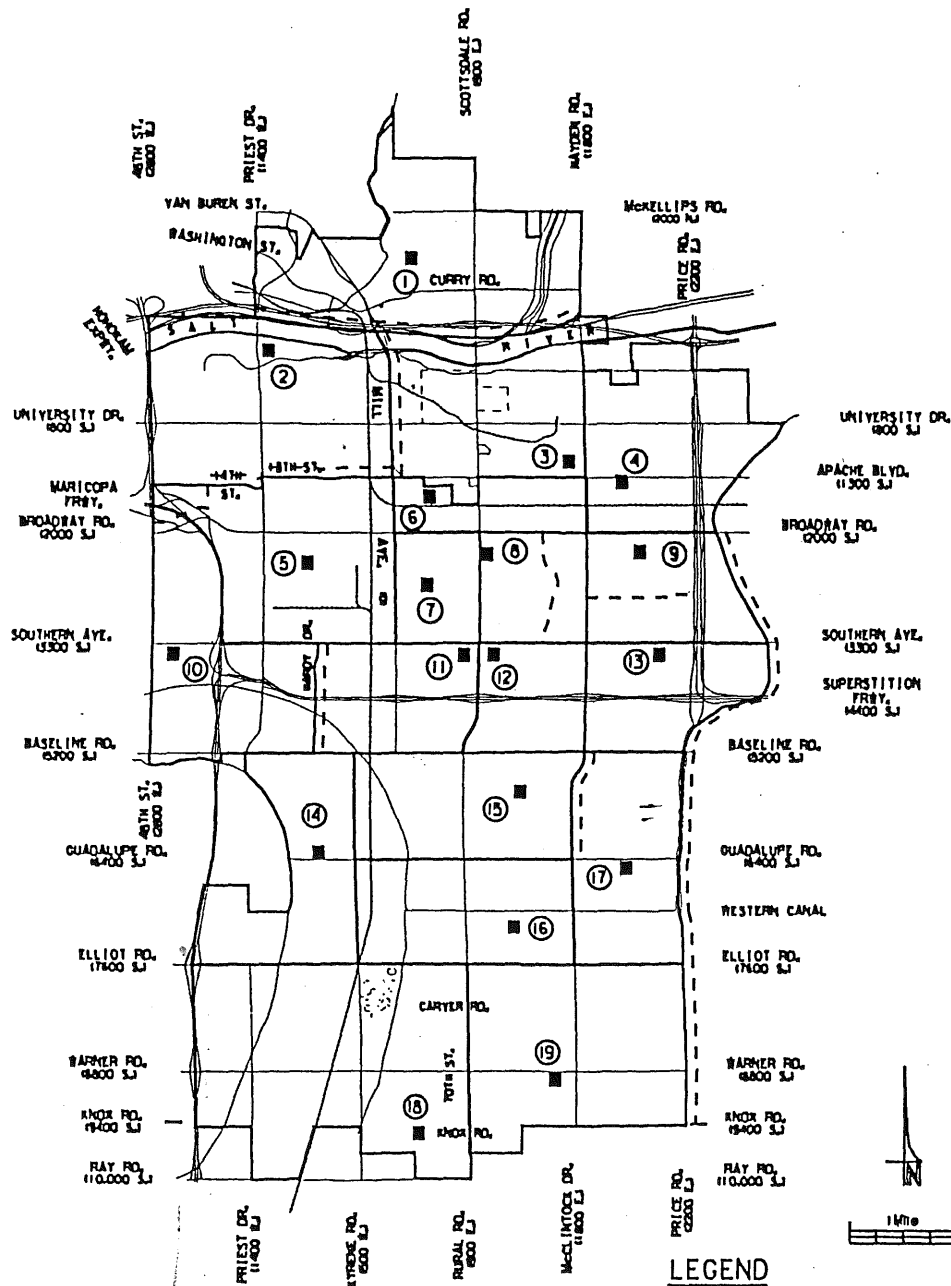
