CHARTER AMENDMENTS APPROVED AT SPECIAL  
ELECTION OF MAY 14, 1968

This is to certify that the attached amendments were approved by a majority of the qualified voters of the City of Tempe at a Special Election held on May 14, 1968. The qualified electors ratified the amendments by the following vote:

Following ratification by the electors, the Council of the City of Tempe canvassed the returns of the election on May 20, 1968, certifying the above results as true and in accordance with law.

These four charter amendments were approved by the Governor of the State of Arizona on June 3, 1968.
