   -IN FLUX located at the Tempe Transportation Center, 200 E. 5<sup>th</sup> Street will be installed
  - -IN FLUX located at the Tempe Transportation Center, 200 E. 5" Street will be installed in late January. Artist Pete Goldlust will unveil his artwork, *Cycle Ops*, and hand out free cups of coffee while he talks about his art on January 30, 2013. <a href="www.influxaz.com">www.influxaz.com</a>
  - -Continue to search for a south Tempe location for IN FLUX and will inform the TMAC members if an agreement is reached.
  - -Green Business Expo will take place on Saturday, Jan. 19, from 10 a.m. 2 p.m. at the Tempe Center for the Arts. As part of the Green Business Expo, artist Jeff Zischke will install his temporary public art, *Nodal Constellations*, in the reflecting pool at TCA until Feb. 4. Nodal Constellations uses solar technology to create glowing, floating art. www.tempe.gov/tcagreen
  - -Requested assistance from TMAC members to collect public art condition reports including photographing and tracking the latitude/longitude for each artwork. TMAC members asked to record volunteer hours spent collecting the information.

## Agenda Item 6 - Arts Grants Coordinator's Report

Carley Conder, Conder/dance Director gave a report. Discussion highlights included:

 Carley Conder is an Arizona native. She received a B.F.A. in Ballet and an M.F.A. in Modern Dance from the University of Utah. Carley is currently a Faculty Associate at Arizona State University, Adjunct Faculty at Scottsdale Community College and has served as Visiting Faculty at Brigham Young University.

- -CONDER/dance is Tempe based and has full performance seasons as a partnering organization at Tempe Center for the Arts. Rehearsals take place at Terpsichore Dance Center in Phoenix.
- -In 2007, CONDER/dance assumed a new role as curator and presenter as the company began the annual festival Breaking Ground, a showcase for new and established choreographers and filmmakers.
- -Breaking Ground 2013 on Friday, January 25 and Saturday, January 26; at 7:30 p.m. located at Tempe Center for the Arts. <a href="https://www.conderdance.com">www.conderdance.com</a>
- Pat Curtin and Jerry Veatch, Tempe Community Chorus Board Members, gave a report.
   Discussion highlights included:
  - -The Tempe Community Chorus (TCC) lead by Director, Cary Burns, and accompanist, Mary Sieverthas have been singing choral music in the Valley since the 1991.
  - -Perform all over the Valley with one major concert and 2-4 smaller concerts. TCC has performed at the Kerr Cultural Center in Scottsdale, the Tempe Center for the Arts, and a variety of churches in the area.
  - -There are 90 chorus members with varying experience levels. TCC members love to sing and work towards improving their musical skills.
  - -Music type includes something for everyone, from choral classics, contemporary hits, pop music, historical gospel music, spirituals written during the Civil War era, Broadway show tunes, movie theme songs and jazz music.
  - -TCC rehearses Monday evenings at the University Presbyterian Church in Tempe
