#### Agenda Item 4 - Arts Grants Report

- Hotchy Kiene welcomed representatives from Arizona Academy of Performing Arts and Childsplay.
- Steve Martin, Childsplay, Inc. Managing Director, and Sarah Sullivan, Childsplay, Inc. Communications Specialist, presented information related to Childsplay's operations, overall artistic quality, impact on the Tempe community, fundraising efforts as well as the success and history of the organization.
- Steen Allard-Lawson, Arizona Academy of Performing Arts Board Secretary, presented information related to Arizona Academy of Performing Arts' operations, overall artistic quality, impact on the Tempe community, fundraising efforts as well as the success and history of the organization.
- Maja Aurora reminded the Tempe Municipal Arts Commission (TMAC) members that the Art Grants Panel Review for fiscal year 2013-2014 took place on May 17; Aurora described the panel process and reported that the panel reviewed the 17 art project grant applications.
- M. Aurora thanked the TMAC members for their meeting attendance and described the
  arts grant process, as well as the role of the TMAC's award recommendations being
  forwarded to the Tempe City Council for review and approval.
- M. Aurora further presented the Arts Grants Review Panel's award recommendations;
   M. Aurora stated that the recommendation values for the arts project grants were calculated using the median value of each grant established by five voting members of the 2013-2014 Arts Grants Review Panel.
- TMAC members recommended the funding of 16 arts grants, 14 arts project grants and 2 organizational development grants for a total of \$146,639.
- TMAC members recommended three arts project grants be denied funding as the applications did not meet Tempe-specific criteria outlined within the City of Tempe Arts Project Grant application material.

MOTION: Frank Williams moved to approve recommendation to fund 16 arts

grant applications for the fiscal year 2013-2014.

SECOND: Janis Webb seconded.
