Agenda Item 1 - Call to Order

Kelly Nelson, TMAC Chair, called the TMAC meeting to order at 6:05 p.m.

Agenda Item 2 - Approval of the August 13, 2014, Commission Minutes

Agenda Item 3 - Chairperson's Announcements

- Kelly Nelson, TMAC Chair, made the following announcements:
 - -Meeting locations will be changing over the next few months: October Downtown Tempe Community offices, November Tempe Center for the Arts, December No meeting
 - -The October meeting will include updates on the Arts & Culture plan
 - -The November meeting will include details about the Tempe Center for the Arts 1/10 of 1% tax
 - -Working towards scheduling an informal meet & greet with between TMAC and the newly combined Historical Museum and Library Advisory Board

Agenda Item 4 - Bradley Manor Townhomes Association, Neighborhood Grant

- Gracie Valenzuela & Angel Campos, Bradley Manor Board Members, discussed their
 effort to beautify the Bradley Manor community, and create a community identity with the
 help of the Maryanne Corder Neighborhood Grant Program's \$10,000 allocation. As a
 Homeowners Association, Bradley Manor is required to match grant funds. They have
 contracted artist Joan Baron to create artworks that must be completed by June 30,
 2015.
- Joan Baron, Artist, described her proposal to fabricate and install entrance signage at
 two locations. The signs will be fabricated of concrete, slump-block, tile, steel, and Plexiglass, will identify "Bradley Manor" in words, and will incorporate the four colors
 designated to each of the four community quadrants. Baron will also work with the
 grounds crew to create swales in the landscape that will retain rainwater to encourage
 healthy landscaping.

Agenda Item 5 - Brentwood/Cavalier NA, Neighborhood Grant

- Paul Hubbel & Heather Dessel, Artists, described their proposal to create sculptures
 that harken 1960s exuberance, to be installed in the southernmost and northernmost
 median islands on College Avenue, marking entry points into the neighborhood. The
 "simulated fountains" will be fabricated of steel rods, have a reflective coating, and stand
 about 20' tall.
- The Maryanne Corder Neighborhood Grant Program will provide \$10,000 of funding, and does not require Neighborhood Associations to match funds. The project must be completed by June 30, 2015.

Agenda Item 6 - Neighborhood Grant Program Updates

 Maja Aurora, COT Arts Coordinator, provided update about the Maryanne Corder Neighborhood Grant Program. Homeowner associations are not required to match grant funds if a proposed project is within a city park. Grant Workshops will be conducted this fall by Neighborhood Services.

Agenda Item 7 - Character Area Plans (Kiwanis/The Lakes and Corona/South Tempe)

- Nancy Ryan, COT Project Management Coordinator, outlined the identification of eight Character Areas of Tempe, intended to define how the community envisions private development and city projects within the character area, and what distinctive attributes are different from neighboring areas. Details include:
 - -The first two areas of focus, chosen by City Council, are Corona/South Tempe and Kiwanis/The Lakes. These first areas will serve as pilot projects, defining reference points for subsequent areas.
 - -Character Areas help identify what the community deems important, the need for CIPs and additional amenities, and a path for future strategies and priorities.
 - -The Community Development Department will have a draft Character Area Plan ready in October. The final Plan is expected to be complete in January of 2015.

 - -Docents will be stationed near Tempe Public Art sites during high traffic events -Launch of the program would happen during the fall 2014 Tempe Festival of the Arts, with stations planned at three sites around downtown Mill Avenue. Kate Hastings,
- Managing Director of the Festival, is very supportive of this program.
