The <u>Arts and Culture Commission</u> typically meets on the second Monday of the month at 6 p.m., except in July and August.

The **Audit Committee** meets as needed to perform its duties but shall meet not less than twice annually.

The **Aviation Commission** typically meets on the second Tuesday of the month at 6:30 p.m.

The <u>Board of Adjustment</u> meets as needed, typically on the fourth Wednesday of the month at 6 p.m. A study session is usually held at 5:30 p.m. the same day.

The **Commission on Disability Concerns** typically meets on the first Monday of the month at 6:30 p.m.

The <u>Desert Conservation Commission</u> typically meets in February, April, June, August, October, and December, usually on the first Tuesday of the month at 3:30 p.m.

The <u>Development Review Commission</u> typically meets on the second and fourth Tuesday of the month at 6 p.m. A study session is usually held at 5:30 p.m. the same day.

The **Enhanced Services Commission** meets as needed, usually quarterly, on the third Tuesday of the month at 8:30 a.m.

The **Family Justice Commission** typically meets on the third Tuesday of the month at 4 p.m.

The <u>Fire Public Safety Personnel Retirement System Board</u> typically meets on the first Thursday of the month at 2 p.m.

The **Hearing Officer** typically meets on the first and third Tuesday of the month at 5 p.m.

The Historic Preservation Commission typically meets on the second Wednesday of the month at 6 p.m.

The <u>Human Relations Commission</u> typically meets on the second Tuesday of the month at 6 p.m.

The **Industrial Development Authority** meets approximately quarterly or more frequently as needed.

The <u>Joint Review Committee</u> typically meets on the first Wednesday of the month at 6 p.m. A study session is usually held at 5:30 p.m. the same day.

The **Judicial Advisory Board** meets as needed.

The <u>Library Advisory Board</u> typically meets on the first Wednesday of the month at 6 p.m., except in July and August.

The <u>Mayor's Youth Advisory Commission</u> typically meets on the second and fourth Tuesday of the month at 5:30 p.m. during the school year (September – May).

The **Merit System Board** meets as needed.

The **Neighborhood Advisory Commission** typically meets on the first Wednesday of the month at 5:30 p.m., except in January and July.

The <u>Parks, Recreation, Golf, and Double Butte Cemetery Advisory Board</u> typically meets on the third Wednesday of the month at 6 p.m.

The <u>Police Public Safety Personnel Retirement System Board</u> typically meets on the first Thursday of the month at 2 p.m.

The **Risk Management Trust Board** meets as needed.

The **Sustainability and Resilience Commission** typically meets on the third Monday of the month at 4:30 p.m.

The **Technical Code Advisory Board of Appeals** meets as needed.

The <u>Transportation Commission</u> typically meets on the second Tuesday of the month at 7:30 a.m.

The **Veterans Commission** typically meets on the second Wednesday of the month at 6 p.m.
