Agenda Item 1 – Call to Order

The meeting was called to order at 5:35 p.m.

Agenda Item 2 - Public Comment

There was no public comment.

Agenda Item 3 – Consideration of Minutes: February 4, 2015

Commissioner Adams made a motion to approve the February 4, 2015 minutes and Commissioner Munch seconded the motion. The motion passed unanimously.

Agenda Item 4 – Neighborhood Award Nominations Group Review and Voting

An initial tally of commissioner votes was taken for each of the three award categories followed by a significant amount of discussion regarding nominees and nomination contents for each category.

Commissioner McNamara made a motion to nominate Ken and Janet Seegren for the Neighbor of the Year Award. Commissioner Ramsey seconded the motion and a vote was taken. The motion was unanimously denied.

Commissioner Ware made a motion to award Raveen Arora the Neighbor of the Year Award. The motion was seconded by Commissioner McNamara and passed unanimously. Mr. Arora is the first business owner/stake holder to receive this award.

Chair Robert emphasized that just because there is a Chuck Malpede Award does not mean commissioners need to award one every year.

Commissioner Adams made a motion to award Barbara Sherman the Chuck Malpede Award seconded by Commissioner McNamara and the motion passed unanimously

Commissioner Buell made a motion to award the Cooper and Lauer residence the Golden Shovel Award seconded by Commissioner Ware and the motion passed unanimously. The involvement of the entire family and the before, during and after pictures provided were noted. Commissioner McNamara confirmed she will provide the winner's golden shovel as in prior years.

Commissioner Korbeck made a motion to award the O'Connell Residence the Property Beautification Award which was seconded by Commissioner McNamara and passed unanimously.

Commissioner Korbeck made a motion to award the Browns and the Shorts with Golden Rake Awards, the motion was seconded by Commissioner McNamara and passed with seven yea votes and 2 opposed. Staff will notify Tony Miano, Public Works Solid Waste Services Manager who will provide the Golden Rakes.

<u>Agenda Item 5 – Character Area Update</u>

Staff distributed the public meeting Apache/Character Area 4 and Character Area 5 schedules for the entire public meeting series. The Preliminary Organizational and Planning Meeting held jointly on February 18 at the Tempe History Museum for neighborhood and homeowners' association, business and community leaders from each area was well received and attended. Approximately 30 potential program ambassadors attended.
