- K. Nelson presented several announcements:
 - -ASU Alumni Magazine included an article about public art on their Tempe and West campuses. Maja Aurora, Tempe Arts Coordinator, was featured as the Tempe Public Art Coordinator and ASU Alumna.

 - -The Northern Trust Company, a tenant in the Discovery Business Campus, will soon enter into a naming agreement with the City of Tempe through a 20-year GPLET lease agreement. The savings TNTC will realize from the GPLET will be placed in a future endowment fund that will provide approximately \$7.3 million to the TCA over a 20-year period.  - -the interactive video art including projection and computer equipment has become unreliable and in some cases completely non-functioning
 - -the artwork is site-specific; relocation of the artwork is not an option
 - -the City of Tempe will provide Jim Campbell with 60 days to respond to the letter

 - -the Tempe Festival of the Arts spring brochure announces the TMAC Arts Docents

 - -TMAC members decided on white TMAC lettering on a blue shirt which will be ordered in time for TMAC art docents to wear for the Festival of the Arts in March
 - -Rob Moore is compiling photos and information for creating a Downtown Tempe Public Art Map, which will be a useful tool for docents stationed at events

Agenda Item 9 - Art in Private Development Ordinance

- **C. Cirillo-Ching** initiated a conversation about the relationship of art and architecture within AIPD, the assertiveness of the ordinance, and in-lieu contributions by developers. TMAC comments include:
 - -employing the artist at the beginning of the architectural design stage could produce well integrated art and/or a building that is more artistically interesting than having a standalone sculpture
 - -the verbiage of the ordinance could assume higher expectations of the artist and developer with more assertive art requirements, in an effort to discourage plop art
 - -TMAC should wield more influence in dictating the direction of the art, and determining the artistic caliber of proposals
 - -in-lieu contributions could be earmarked for larger monumental municipal arts projects -broader definitions in the ordinance could include renovations of developments
