Agenda Item 5 - IN FLUX, Public Art

 Maja Aurora, COT Arts Coordinator, presented IN FLUX Cycle 6. Discussion highlights included:

-Call to Artists for Cycle 6, 2015-2016, would be released in August with selection panel in September. Installations would occur in January and remain installed October, 2016.

-Budget of \$4,000 per location and up to four spaces

-Continuing to work with Tempe Marketplace and Downtown Tempe Authority. TMAC members also suggested other possible locations including Arizona Mills, Apache/Light Rail corridor, Guadalupe and McClintock intersection, and McClintock and Southern intersection.

She typically paints in the morning time with the help of two apprentices who are high school students -promotion will begin later in the week with the help of the City's public information officer. M. Aurora encouraged TMAC members to help get the word out about the mural and to visit Lauren while she's painting.
