Item 2 – Public Appearances

David Bush, is a City of Tempe resident and therapist in private practice for 30 years. For the past 9 years he has been a trauma specialist and has developed a resource to cure many cases of Post-Traumatic Stress Disorder (PTSD). Therapy is a combination of Eye Movement Desensitization and Reprocessing (EMDR) as well as a number of other psychological concepts. Mr. Bush has used this therapy on a few hundred people. CD's are free to Tempe Police Department for the month of October. Upon receiving email, \$15 purchase fee will be refunded. Shared a letter of one woman's experience.

- All victims deserve the same level of attention as high-profile cases
- Testing kits need to be available for all sexual assault cases
- Statistics are needed related to number of crimes, number of cases prosecuted, and number of successful outcomes
- Community-based family advocacy center, rather a police-based one
- Mentoring programs for victims and offenders
- Training for judicial and non-judicial employees
- One Stop Shop, a centralized location for services and a safe haven
- Prevention services for children
- Transportation
- Housing
- Pet foster care
