# Agenda Item 3 - Approval of the September 9, 2015 Commission Minutes

#### Agenda Item 4 - Chairperson's Announcements

- **K. Nelson** shared the following announcements/comments:
  - The Tempe Police Department and Tempe Fire, Medical, Rescue Department will be holding a Cook-Off to raise funds for their Public Safety Memorial on October 17, 10am-2pm @ Culinary Dropout, 149 S Farmer Ave, Tempe, AZ 85281. Tickets are \$50 and can be purchased at www.TempePoliceFoundation.org
  - Julie Akerly has joined Tempe Public Art as an Arts Assistant and will be taking notes at future TMAC meetings.
  - K. Nelson will conduct a reading at Changing Hands Book Store in Tempe on Friday, October 16, 2015 at 7pm.

# <u>Agenda Item 5 – Neighborhood Grant for Sandcastle, Lake Park Villas and Runaway</u> Point Neighborhood Associations

- Lyle London, Artist and Nori Muster, Neighborhood Representative shared information and artist plans for the Neighborhood Grant project to be built on the median on Lakeshore Drive near the community center. Discussion includes:
  - The project is a dedication to Lakes Community founder, Arnold Dahlberg.
  - The proposed design is a steel sculpture of an Egret taking flight.
  - The artist confirmed that plans have been approved by a structural engineer.
  - Members of TMAC recommended considering solar powered lighting, installing base further into the ground, and considering the visibility of the dedication text.
  - Project Deadline is June 30, 2016 with expected completion in March 2016.

#### Agenda Item 6 - WUD Well Site #1 Mural

- Jake Early, Artist shared information and plans for a mural to be painted at the WUD Well Site on College Ave, adjacent to Daily Park. Discussion included:
  - The mural design is a timeline of Tempe and the neighborhood.
  - TMAC members appreciated artist's use of color, pattern and imagery.
  - The City will work with the nearby neighborhoods to promote the project.
  - Completion is expected in December 2015/January 2016.

#### Agenda Item 7 – Public Art Docents

- K. Nelson received a go-ahead from TMAC to schedule Public Art Docents at:
  - Tempe Public Art projects: Tempe Roots Utility Box, Greetings from Tempe, and Three Rabbits
  - Docents will be on site from 12-1pm at the Tempe Festival of the Arts from Dec

  - Docents will hand out updated maps and magnets
  - Docents will wear shirts that show their affiliation with the commission and the City of Tempe. Design will be discussed at a future meeting.

## <u>Agenda Item 8 – Broader Mandate & Specific Membership Qualifications</u>

 K. Nelson led a discussion about selecting specific membership qualifications for TMAC. A form was given to TMAC member with a list of potential membership qualifications. K. Nelson collected forms for analysis and will share results at a future meeting.

# Agenda Item 9 - Public Safety Memorial

- Maja Aurora, Arts Coordinator, presented information about the Public Safety Memorial public art project to be placed at Tempe Town Lake on the corner of Mill Ave. and Rio Salado Pkwy.
  - TMAC members expressed a strong, unanimous opinion that the proposed location does not seem to be ideal for the project and requested that this feedback be shared with Community Services departmental management. The Commission's specific concerns included:
    - The entrance to Tempe Beach Park is a place of transition, and may not promote the intended purpose of contemplation and observation.
    - The memorial's intent seems to require a location that allows family members space for quiet reflection. Creating a "Court of Service" space as a memorial could allow for a more contemplative experience.
    - A figurative memorial at the entrance to the park does not seem to reflect the recreational or celebratory nature of events that occur at Tempe Beach Park or on Mill Avenue.
    - There is limited space for people to gather at the entrance to the park. Perhaps there is a more suitable location within Tempe Beach Park that would allow for memorial congregations and ceremonies lead by the Tempe Fire, Medical, Rescue Department and Tempe Police Department.

## Agenda Item 10 - Update; Public Art

- M. Aurora presented updates about current public art projects.
  platFORM: The first platform location at Tempe Beach park was installed in time for the official opening and ribbon-cutting for the Bike Corral. TMAC members Robert Moore and David Lucier were in attendance as well as the artist team.
  - -The second platFORM location at the Hayden Flour Mill is scheduled to install on Friday, October 23, 2015. <a href="http://www.platform-az.org/">http://www.platform-az.org/</a>
