Agenda Item 6 – 2016 Indian Gaming Grants- Council Priorities

A preliminary list of five potential park projects has been submitted to the city manager to be considered to receive funding from Indian Gaming Grants. These are based on tribal priorities and are either a CIP project or otherwise directed by council. The projects submitted by Public Works include:

- Off leash dog park
- Little League field in south Tempe
- Kiwanis Park fishing ramadas
- Arizona Historical Society parking area lighting to deter crime
- Moeur Park historic ramadas renovation

A future update will be provided to the board as the process moves forward.

<u>Agenda Item 7 – Update on Parks CIP Process – Projects Being Accelerated to 2015/16</u>

No change to report in the CIP process since last meeting, instead staff provided a presentation to the board on the projects in the 5-year plan that are being accelerated to begin in 2015/16. These projects are able to be accelerated as a result of Council direction to allocate additional funding to park projects from land sale revenue. Projects include:

- Playgrounds- Dwight and Svob
- Restrooms- Daley design and construction plus Benedict design
- Ramadas- Papago
- Sport Courts and Paths- Selleh (path), Meyer (path) and Harelson (2 tennis)

- Athletic Field Lighting- Daley ballfield + BB, Stroud soccer + BB, Corbell soccer + BB, Svob soccer, Harelson tennis (all projects include design and construction). Also, additional funding for KRC tennis.
- Lighting and Electrical- Birchett, Daumler, Erhardt, Meyer South, Moeur, Waggoner and Dwight.
- Lake Edge- Papago design and construction and Kiwanis design.
- General Infrastructure and Site Furnishings- Mortar sand replacement at 15 parks.
