<u>Agenda Item 3 – Introduce Tony Miano- Deputy Public Works Director- Field</u> Operations

Tony Miano, newly promoted Deputy Public Works Director- Field Operations was introduced to the board.

Agenda Item 4 – Public Safety Officer Memorial in Tempe Beach Park

A memorial to honor fallen firefighters, police officers and K9's is currently proposed to be placed in the entrance of Tempe Beach Park. Through the RFQ process over thirty submittals were received and narrowed down to four artists. The final four have been asked to provide proposal renderings at which point an artist will be selected by the established review committee on March 21st. Staff will present rendering to the board in April after artist selection is complete.

Agenda Item 5 – Kiwanis Recreation Center Solar Project

Kiwanis Recreation Center Solar Project will begin construction in mid-March and will take 6-8 weeks to complete. This project will create parking canopies which cover 156 parking spaces, similar to what was done at the library complex.

A presentation of slides was presented to the board:

- 10-year Parks CIP Funding Scenarios- showed reducing and eliminating the backlog of deferred capital replacement and for our CIP request to begin funding Levels 3 and 4 in FY 20/21.
- Asset Management vs Recreational Value- showed once we reach FY 20/21 when
 the backlog has been extinguished, the funding for asset management decreases to
 \$2M and for recreational value increases to \$3M, for an annual funding level of \$5M.
 Until then staff has requested for Recreational Value improvements of \$1.2M per
 year.
