#### Agenda Item 1 – Consideration of Meeting Minutes

#### Agenda Item 2 – Public Appearances

Deb Gain Braley, Tempe resident requested a future agenda item addressing camping/fire permits and regulations. In addition, options for insurance for neighborhood associations.

#### <u>Agenda Item 3 – Papago Park Preserve Designation</u>

Darlene Justice, North Tempe Neighborhood Association provided background material to the board and discussed the process to designate Papago Park as a preserve. In December 2015, a petition with more than 1,100 signatures was presented to the Tempe Mayor and City Council. The petition asks Tempe Mayor and Councilmembers to establish a preserve for the remaining Sonoran Desert in Papago Park. This includes Tempe's Protected Park Zones and Tempe's Riparian/Aquatic Zones, as outlined in the Discover Papago Park Master Plan. The proposal will be presented to council at the April 7<sup>th</sup> Issue Review Session at 4:00 pm.

# Agenda Item 4 - Landscape Masterplan Process

Bonnie Richardson provided a presentation to the board on the Tempe Library and Cultural Center Landscape Master Plan. This is a 5-year CIP project and will include the following:

- Installation of solar canopies & panels
- Comprehensive Landscape Master Plan
- Lighting & electrical improvements
- Construction of new irrigation system
- Parking lot improvements
- Installation of trees & landscape

The goal of this project is to revitalize the complex by; enhance & update appearance, improve visitor experience, increase safety, expand & reinvent use of exterior spaces and attract new visitors to the cultural campus.

Next steps include; data collection, assessment of the health & function of landscape & hardscape, consideration of new activities & uses and citizen involvement.

Information will be brought back to the board as the process moves forward.

#### Agenda Item 5 – Lighting Project Updates

Craig Hayton provided an update on various lighting projects going on throughout the city which included the following:

- Tempe Town Lake Marina Area Sail light pole updates that were damaged during monsoon storms
- Meyer Park Area Meeting, Thursday, March 24<sup>th</sup> from 6-7pm, Tempe History Museum, Community Room, 809 E. Southern Ave This small scale pilot program will begin installing LED street lights and park lights the week of April 4<sup>th</sup>. The street lights will be installed on Dorsey Lane between Alameda and Malibu. The park lights will be installed in the grassy area south of the playground.
- Hollis Park Area Meeting, Thursday, March 24<sup>th</sup> from 6-7pm, Tempe History Museum, Community Room, 809 E. Southern Ave This small scale pilot program will begin installing LED street lights and park lights the week of April 4<sup>th</sup>. The street lights will be installed on Dorsey Lane between Alameda and Malibu. The park lights will be installed in the southeast corner of the park, where the concrete pathway meets the playground.

 Indian Bend Light – Central overhead light pole will be replaced with two LED heads on existing pole.

Following the pilot program staff is seeking input from residents prior to moving forward with additional change outs to LED lights.
