#### **PROJECT NARRATIVE**

In the space provided below, please describe specifically how the City of Tempe's funds will be used:

Hudson Manor Neighborhood Association is excited by the opportunity to continue to build upon the neighborhood improvement masterplan we developed in 2012 with this 2016-17 grant application. We thank the city for last year's support of our 2015-16 grant application with which we successfully install one new landscaped traffic circle at the intersection of Elm/Williams Street, building upon two others installed in the previous grant cycles at Elm/Hudson Streets and Oak/Hudson Streets. In the past 2 years, we have received much kudos from the neighbors due to the traffic slowing effect the circles have provided, and we have enjoyed seeing the landscape grow.

This year at Oak/Williams Streets we would like to install the last of the 4 traffic circles at these major intersection crossings in our neighborhood, in order to further traffic calming and beautification of the neighborhood.

- 1. Please describe how this project meets each of the guidelines listed:
  - A. Improves health and safety of residents:

As Apache Boulevard continues to be developed with new large-scale multi-use projects, Hudson Manor is proud to maintain and revitalize its small-scale, single family character that was established 60 years ago. By creating landscaped roundabouts at our cross streets, we can enhance the public right of way and create thresholds that mediate between the high intensity activity of Apache Boulevard and the slower pace with the neighborhood.

B. Benefits a significant number of residents and/or the City at large:

The benefit is in the roundabouts' traffic calming ability as well as ability to strengthening our identity of place.

C. Addresses a known neighborhood deficiency:

This project will improve the quality of our neighborhood atmosphere as the proposed locations at these crossings see frequent vehicular traffic.

D. Complements other neighborhood projects (private or City):

The project will complement the traffic circles installed in 2014 and 2015 in Hudson Manor as well as within the Maple Ash and Mitchell Park neighborhoods, providing an aesthetic continuity within the city.

E. Provides an environmental benefit, such as water and/or energy conservation:

The traffic circles provide multiple landscaped nodes to increase shade and more greenery in the neighborhood, decreasing the heat-island effect of the asphalt streets.

F. Enhances the aesthetics of the neighborhood:

With the circles installed the physical scale of the streets are made smaller, more appropriate for bike and pedestrians.

G. Accessible to all members of the community:

The entire neighborhood benefits from the traffic circles with increased safety of the traffic slowing, a more positive image of our neighborhood with the increased greenery, and an opportunity for community involvement in planning and planting the new landscape.

Describe how members of the community have been directly involved in the development of the project.

In October of 2012, at Hudson Manor's GAIN night, the neighborhood looked together at an aerial photograph of the neighborhood streets and properties to talk about where we want to make improvements. Lots of good ideas where discussed and a masterplan of improvements was developed. Traffic calming features are part of the masterplan and last year neighbors Frank Farina, Maria Salenger, Dan Childers, and Phil Amorosi successfully installed the third circles in the neighborhood with the 2015-16 grant. This year the neighborhood looks to further complete our goal of a circle at each of the major crossing with the Oak/Williams intersection. In March of 2016 neighbors provided notice of support via signed postcards (see attached).

3. Grant funds can only be used for the capital improvement project, not maintenance. Please describe specifically how the association intends to maintain the project if funded.

The traffic circle is proposed with low-water use landscape that does not require irrigation. Neighbors volunteer to water the plantings for the first year as it is established and perform monthly trimming and weeding thereafter.

4. If your association has previously received grant funds, please share how they have impacted your neighborhood.

As stated previously, from the 2014-15 and 2015-16 grants of previous years we have received many thanks for installing the first three circles which have slowed incoming traffic considerably and added greenery to the streetscape.

In addition, our neighborhood was the first to receive funds to paint addresses on curbs for easy ID.

We also got a grant to install addresses on gates in back alleys to make it easier for police and fire to locate houses.

We had a fence installed to separate our neighborhood from the railroad tracks, keeping out transients.

We created art entry posts to identify Hudson Manor.

We had street lights installed in our 3 cul de sacs for public safety.

ADA ramp improvements at all sidewalks, this also helped the many moms with strollers that come to the park.

Hudson Park renovation, we used 4 years of neighborhood grants to plan and keep the process moving by starting much needed sidewalks and creating a labyrinth while we waited for CIP funding for total renovation.

## TREE WORKSHOP & EXPO SATURDAY, FEBRUARY 27


