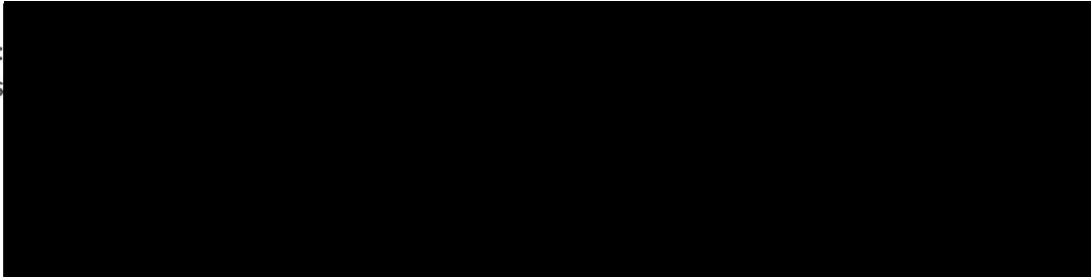

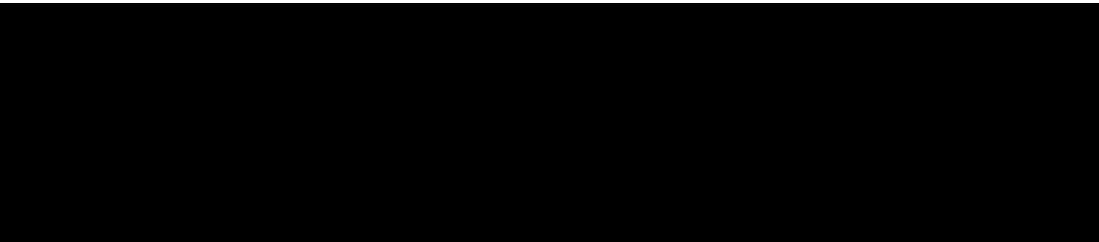

PROJECT NARRATIVE

**Project 2 OF 2 submitted for Grant Request
SECOND VOTED – STREET SIGN TOPPERS WITH NEIGHBORHOOD NAME**

In the space provided below, please describe specifically how the City of Tempe’s funds will be used:

This request is to purchase street sign toppers with our neighborhood name to be placed above our current street signs. Papago Park View Neighborhood is an old neighborhood that has just recently become a separate part the Tempe Neighborhood Association Program. Previously we considered ourselves simply part of NTNA, but in an attempt to maintain voting rights in NTNA, Papago Park View was formed. Our name was College NA according to city literature, but that has been confusing with neighborhoods south of ASU. In February the neighborhood voted to change the neighborhood name to Papago Park View Neighborhood

These uniform signs throughout the neighborhood should help residents begin to associate their residence as part of this established neighborhood. Neighborhood cohesiveness should help us with our efforts to increase participation in Block Watch, GAIN and other Tempe sponsored activities. Neighborhood cohesion correlates positively with a neighbors willingness to be active for the betterment of the common good, the neighborhood and city according to a University of Chicago study.

1. Please describe how this project meets each of the guidelines listed:

- A. Improves health and safety of residents: Increasing neighborhood cohesion will encourage neighbors to participate in things like block watch and activities that help the common areas of the neighborhood. When neighbors keep track of each other, aging in place, crime prevention and sharing of information in general becomes a little more possible, and easier.
- B. Benefits a significant number of residents and/or the City at large: Strong active neighborhoods keep track of crime, and help neighbors stay informed as to city communications. These activities can help the city reduce needed services.
- C. Addresses a known neighborhood deficiency: This neighborhood is relatively young (<1yr), as an active separate Neighborhood Association. Many do not know what this means or how it can help them. Common signs can help people feel like they are part of this whole neighborhood.
- D. Complements other neighborhood projects (private or City): This goes along with the effort to bring neighbors together and getting them active (GAIN).
- E. Provides an environmental benefit, such as water and/or energy conservation: Not really by signs directly, although active neighbors help train each other to recycle and conserve. We trade plants and seeds and share found new recyclers. We help each other carpool or attend as a representative to bring news back to the neighborhood.
- F. Enhances the aesthetics of the neighborhood: Additional signs look nice. They make the neighborhood just a little special. We are not an HOA with a great monument signed entrance. These signs can have some of that same effect.
- G. Accessible to all members of the community: Higher participation rates, possibly lower crime or errant activity leads to less crime management needed. Greater communication of city changes and requirements can lead to easier adopted change and better success probability.

2. Describe how members of the community have been directly involved in the development of the project. Papago Park View Neighborhood had two meetings with mailings notifying neighbors of the opportunity to propose, vote support and prioritize grant request projects. A longer list of projects was prioritized with this project standing out as the 2nd project we could accomplish this year.

3. Grant funds can only be used for the capital improvement project, not maintenance. Please describe specifically how the association intends to maintain the project if funded: Signs will be placed on top of existing street signs. We, neighbors, currently clean existing street signs, benches and poles of graffiti using a kit supplied by Tempe Pd. We will continue to keep these new signs clean as well.
4. If your association has previously received grant funds, please share how they have impacted your neighborhood: This is the 1st grant application that I am aware of, by this neighborhood.
5. Outside of grant projects, please describe any other activities your association has participated in (i.e. GAIN, Adopt-A-Park, food drives, etc.) within the past year.
 - Papago Park View participated in the GAIN event this last year, our 1st year as a separate NA. As part of NTNA we held an environmental fair in Evelyn Hallman Park, on the camping island. Extra donated food, drinks, snacks and water (a van full) was donated to the Tempe Food Bank.
 - NTNA adopted Evelyn Hallman Park. As part of NTNA our neighborhood helped prune along the parks exterior sidewalks. We also participated in an NTNA event to clean Evelyn Hallman Park and pond. Neighbors from Papago Park View regularly pick up trash and fronds in the park as we walk the park.
 - The neighborhood voted in February and is in the process of adopting a path connecting to the park, but have not finalized nor had our 1st clean up yet.
 - As part of NTNA, many of the neighbors packed food for hungry as a team building event last December.
6. What is your proposed timeline for the grant project?

These signs are made by Tempe, in house. I assume we will be in line with any other neighborhood with a grant approved. Of course we will be excited to have the project done, but can wait our turn, as long as completion is by the June 2016 deadline.

Crime Prevention and Block Watch

Within a couple of weeks in November, there were home burglaries on Taylor and McKinley. Other nearby neighborhoods were hit too. Darlene Justus and I met with Detective Shelli Miller, Tempe Crime Prevention Officer.

Most burglaries are through unlocked gates, doors and windows. The city can provide some gate locks; so let me know if you need one. Identity theft is a growing problem. Thieves can find your information in your home, car, mailbox, and unfortunately too many other ways. There are new inexpensive cameras that send an alert via your wi-fi to a cell phone if movement is detected. I'm sure our neighbors have great ideas for keeping homes safe. Bring your ideas to the meeting and share with neighbors.

Officer Shelli Miller will be at the meeting to talk more about events in our neighborhood and how we can avoid becoming victims. We'll have sign-up sheets for Neighborhood Watch if anyone would like to attend a future meeting to get more information and hopefully participate in that program. Neighborhood watch is not nosy neighbors. It is aware and alert neighbors willing to report unusual or suspicious behavior to police. It means having neighbors we know and trust so we can feel more secure when away from home. It can help reduce crime in our neighborhood.

More information is available on the City of Tempe website at www.tempe.gov/neighborhoodgrants Some ideas discussed by neighborhood residents so far include bus stop improvement and communication boards in Evelyn Hallman Park. Shade structures are very expensive, but possibly shade trees could be planted. At the January 23 meeting we'll vote on ideas to move forward into the application process. Depending on our vote, we'll need to work with others in the neighborhood and city for approvals before the application is submitted. Application receipt deadline is April 4, 5pm.

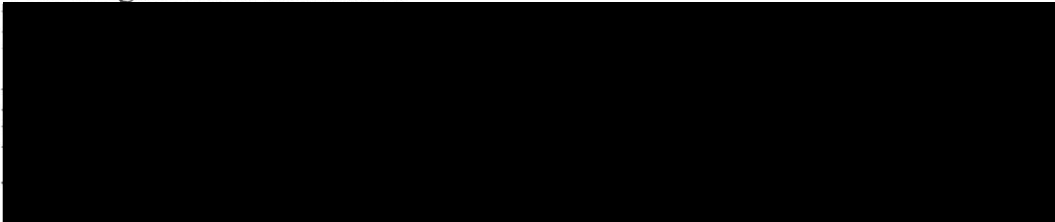

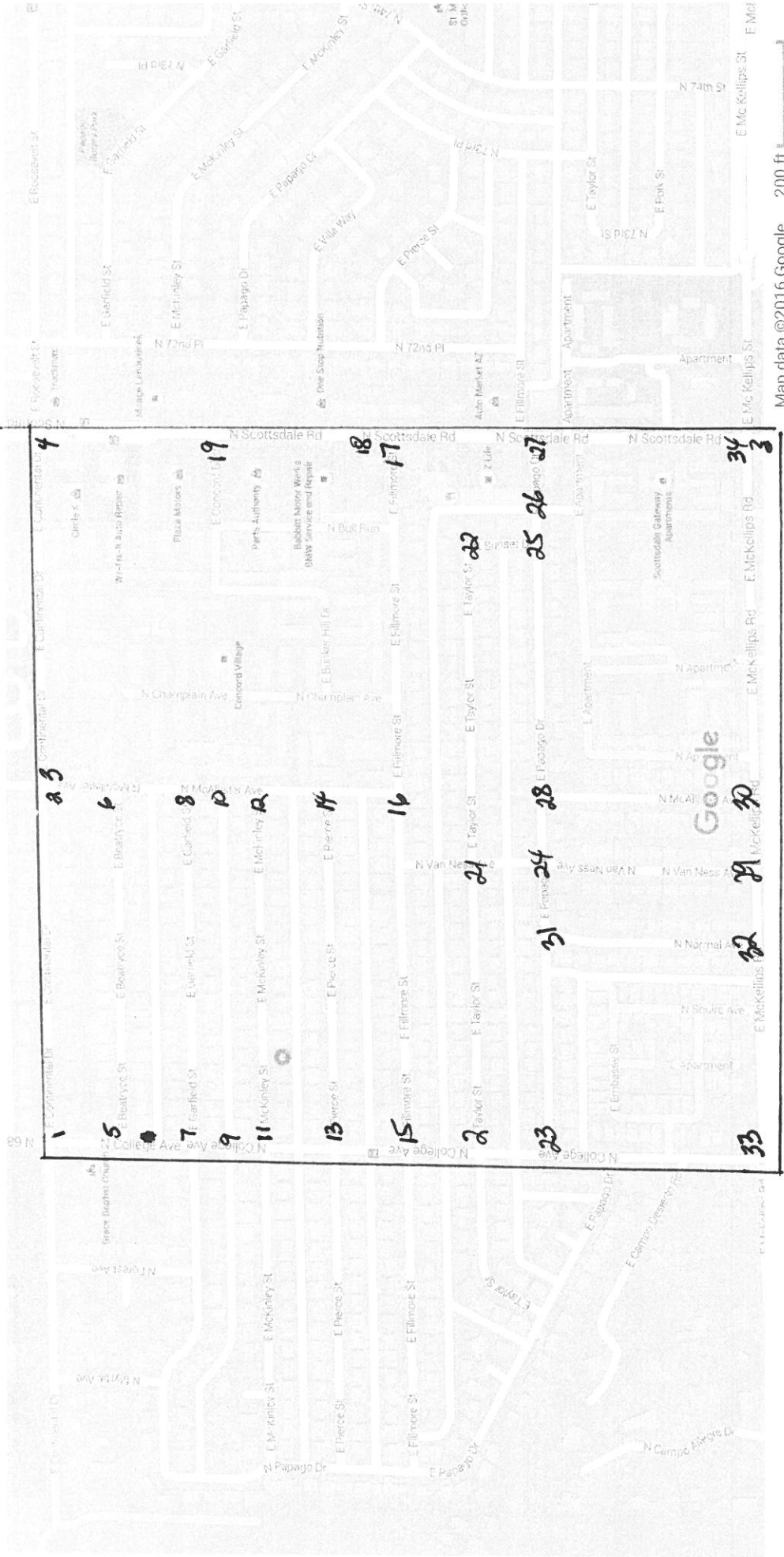
