## Item 2 – City of Tempe Adapted Recreation – Joshua Bell, Sr. Recreation Coordinator

Senior Recreation Coordinator Joshua Bell shared information on recreational programs for youth and adults with intellectual and developmental disabilities. The programs have been successful for decades. They include:

- Camp Challenge June/July for special education students ages 5 to 21
- LEAP: Life Skills enrichment After-School Program (2:00 6:00p.m.)
- Special Olympics Arizona: 9 sports over the year
- Buddy Bowling: ages 8 to adult; multiple divisions
- Classes and special events: Zumba, Friday Night Social Activities

Volunteers are the backbone of these programs and more are always needed. The program could grow but is constrained by budget, space and staffing. They recently applied for a grant for a wheelchair accessible vehicle for transportation to events. Friday events are dovetailed around other similar events in the East Valley – Scottsdale, Mesa, Chandler and others, to facilitate opportunities throughout the month, minimize impact to other programs and cost.

Wish list includes a larger facility that would have sufficient space for a functional kitchen, gym, rooms and outdoor recreation spaces. With a larger budget more staff and educational supplies, such as computers and Chrome books could be purchased. Tremendous funding sources that support the program include Team
