VISION

Using a facilitated and participatory process, Wydale worked with the commission through a brainstorm activity to establish the Commission's vision, answering the question: *What do we want to see in place in 3-5 years as a result of our actions?*

MISSION

Through a facilitated process, the Commission collaborated to draft a mission statement:

The Mission of the Tempe Sustainability Commission is to be a culture-catalyst to provide leadership, education, and guidance on inspirational and transformational sustainability programs and policies to City Council and for our entire community so to foster a healthy and resilient Tempe that positively impacts the region, the nation, and the world.

Incorporating the vision elements, **STRATEGIC DIRECTIONS** were prioritized by the Commission. The three top priorities were identified as 1) Staff resources and 2) Sustainability Plan, and 3) Collaborations.

- Water Conservation strategy/guidelines
- Identify areas and address of greatest need (demographically, environmentally and others)

- Create a City of Tempe/ASU Sustainability Coordinator position
- Sustainability is integrated/ingrained with City front line staff cultural

- Resilience Festival diverse, fun, informative, creative, NAssoc., Cities, business, innovation research)
- Create a network of pioneers committed to sustainable practices across the community
- Survey/mechanism for stakeholders involvement- buy-in (North vs South Tempe)

- Green Building incentives for private development
- Build out and increase access of digital sustainability resources and information
- Development of policy change for public entity savings of capital vs. O&M
- Carbon pricing
- Healthy homes vs. funding for renovation (IEQ/health)
