### <u>Agenda Item 5 – Impacts of Rolling Hills Temporary Closure and Possible Ahwatukee</u> <u>Course Closures on Ken McDonald</u>

Ken McDonald has seen an increase in rounds due to leagues that played at Rolling Hills now temporary using Ken McDonald. At this time there are sufficient openings and staff welcomes extra round opportunities. Concerns were expressed if demand was to increase to a point that the course could not fulfill the requests what the strategic plan would be.
