MINIMUM QUALIFI	CATIONS
Experience:	Two (2) years of experience as a skilled journeyman electrician, including experience with 4160-voltage applications. Electrical repair work with pumps, compressors, engines, and related equipment at a water or wastewater utility is preferred.
Education:	High school diploma, GED or equivalency, supplemented by graduation/completion from/of an accredited electrical apprentice or trade school program or licensure/certification related to the electrical trade.
License / Certification:	 Possession of a valid driver's license. Possession of or required to obtain within six (6) months of hire an Arizona Department of Environmental Quality (ADEQ) Grade 1 Water Treatment Certification, an ADEQ Grade 1 Water Distribution Certification depending on assignment.

ESSENTIAL JOB FUNCTIONS

Essential job functions are the fundamental duties of a position: the things a person holding the job absolutely must be able to do.

To actively support and uphold the City's stated mission and values. To perform a variety of complex technical and skilled electrical work in the planning, installation, alteration, maintenance and repair of equipment for electrical systems in water and wastewater facilities.

OTHER DUTIES AS ASSIGNED

Please note this job description is not designed to cover or contain a comprehensive listing of all activities, duties or responsibilities that are required of the employee for this job. Duties, responsibilities and activities may change at any time with or without notice.

- Follow safety regulations and safe work practices at facilities, including traffic/barricade compliance and confined space entry procedures; adhere to all Occupational Safety and Health Administration and water treatment guidelines.
- Maintain and repair electrical wiring systems, up to and including 4160-volt systems. Perform
 a variety of maintenance tasks on equipment including motors up to 1250 horsepower, coils,
 transformers, power panels and motor control centers and control equipment.
- Install, troubleshoot, maintain and repair various types of luminaries and lighting systems including Ultra-Violet disinfection systems.
- Repair sodium hypochlorite, pumps, meters and generating equipment.
- Test, run and maintain generation equipment and complete documentation for regulatory agency requirements.
- Install, test and maintain various uninterruptible power supply systems.
- Install and maintain water pumps and process control equipment at booster stations, well sites, lift stations and other remote sites.
- Assist staff with trade-specific information regarding electrical systems during routine maintenance, new construction and upgrades; establish operating criteria and standard operating procedures (SOPs) for successful operation of electrical systems.
- Repair and maintain chemical feeders, mixers and controllers.
- Operate electrical troubleshooting and monitoring equipment as needed.
- Maintain and calibrate electrical testing equipment, tools and instruments.
- Ability to troubleshoot and repair equipment controlled by programmable logic controllers.
- Inspect and maintain fuses, buss bars, thermocouples and electrical contacts.
- Inspect and repair relays, time clocks, timers, photocells, contactors, solenoids, pressure switches and thermal overload unit.
- Install and inspect transient voltage surge suppressor units and cathodic protection systems.
- Document and maintain online diagrams for all Water Utilities sites.
- Prepare reports of equipment use, time, materials, parts, supplies and facility equipment failures. Update work order status and condition information into the Computer Maintenance Management System (CMMS).
- Create, update, review and finalize work orders in CMMS.
- Perform Confined Space Entry duties as entrant, attendant and/or Authorized Entry Supervisor as plant duties necessitate.
- Perform related duties as assigned.
