Agenda Item 2 – Approval of Meeting Minutes

Agenda Item 3 – Recap Previous Presentations

Climate Action – Commission discussed the desire to look into City of Phoenix Lead abatement program. Rolf Halden, Sustainability Scientist at ASU, can be a great resource.

Commissioner Monty committed to doing more research, identifying potential partners and work with County and ASU.

Commissioner Wiek shared information from community engagement initiative he recently attended in Toronto. The conference identified a specific large scale engagement process - 250,000 people. He will follow up Shauna Warner on community engagement initiatives to discuss how something of this scale might benefit Tempe. The premise being that often times community engagement only reaches a small percentage of individuals that may not broadly represent the community interest.

Agenda Item 4 - Sustainability Award

Commissioner Hu talked about the sustainability award application form and suggested adding retreat language to populate the introduction. Carol will bring different criteria next month and Commission will select the appropriate award category.

- Discussion about project, program or person awards/nominations.
- Craft a rubric when receiving some applications.
- The rubric will be used by the Commission only to evaluate the criteria and select the point systems.

Agenda Item 5 – 5th Street Project

Don reminded the Commission's desire to cross-pollinate work efforts with other Commissions. The Transportation Commission is working on the 5th Street Project and a partnership opportunity has been identified for these two Commissions to work collaboratively on this project together

Erin Iwersen, Transportation Principal Planner, and Shauna Warner, Neighborhood Program Manager, presented the overview of the 5^{Th} Street Streetscape Project. They talked about:

Shauna will script out the public process including the role of the Sustainability Commission and the milestones for the Sustainability & Transportation Commission together.

Agenda Item 6 – Resiliency Workshop

Braden Kay, City of Tempe Sustainability Manager, gave an update about the workshop. A group from ASU is providing the facilitation and content. He mentioned the major focus of this workshop is to expose the senior management staff at the city to same critical sustainability ways of thinking and resilience concepts. This will help how departments can operationalize these strategies into their practices and tie them back to the City Council strategic initiatives. The workshop is scheduled on Thursday, November 10th.

A series of pre-workshop activities is scheduled to be presented to the city senior management staff. Professor Arnim Wiek, ASU, had already presented the first one to Commission.

Agenda Item 7 – Bicycle Lanes on McClintock Dr.

Commissioner Jung talked about the McClintock bike lane and the possibility of being removed. A presentation to City Council is scheduled on November 3rd.

A motion was made for Commissioners Hawkey, Jung and Kane to draft a letter supporting keeping new McClintock bikes lanes. Letter should include:

- 1. Safety of cyclists
- 2. Benefits of reducing congestion
- 3. Healthy lifestyle promotion
- 4. Reduce air pollution
