No programs or events.

Ms. Borders discussed that after the season the Downtown Tempe Authority will be going back to their Place Making project. The DTA will be identifying how to activate the ten open spaces shown on their master plan and other ongoing programs and research reports. Ms. Borders said that the DTA will be hosting the first International Day of Downtown Reginal Conference in March of 2017.

Ms. Boarder spoke about the Artisan Market and announced that there has been an increase in traffic. There have been about 40 to 45 venders every week. There is a count of guests every hour and a rotation of 30 guests per hour. Also, the DTA has started back up Thursday night concerts. There has been only 1 rain out in October. However, the attendance for this event increases every week.

Don Bessler discussed that there have been several public meeting for the Streetc ar project.

Alex Smith advised that the 1st public meeting was held for the redesign of 5th Street and it was well attended.

Mr. Bessler advised the Commission that there will be an update to the City Council on December 15. There are multiple proposals for venders and off wire solutions for the downtown. Mr. Bessler stated that the schedule for this project is just a planning schedule right now. As the team gets further into the design and a construction contract is assigned then there will be a hard schedule until then there isn't anything happening to indicate that anything is off schedule. There will be 4 different contracts coming to Valley Metro Board and Council for endorsement. There is the car (itself) contract, a Construction Manager at Risk contract to construct, the design contract, and public art contract. The first \$8 million of this project has all gone into preliminary engineering and has taken about 6 years.

Ken Jones asked Mr. Bessler about the process on the traffic study with ASU and can the residences of the neighborhood be able to give input. Mr. Bessler advised that this is not a public process. He explained that this is simply an internal staff and ASU planning tool.

Mr. Levesque discussed current events and projects with the Commission. He announced the recent Character Area meeting had a focus on ASU and the campus connectivity of historic places and integration with Tempe.

Mr. Levesque reviewed the schedule for public hearings at the Development Review Commission, Watermark (Dec. 13).

Ken Jones confirmed that ADP is going to occupy US Airways and that they are going to bring in about 1500 employees. He asked if ADP has contacted DTA about managing parking and Ms. Borders did confirm that they have taken care of that.
