## Agenda Item 5 - Arts and Culture Deputy Director's Report

- Ralph Remington, Deputy Director of Arts & Culture, updated TMAC with the following:
  - TCA presented Batarè on April 7<sup>th</sup> to over 300 guests and received a standing ovation
  - Melanie Holm performed in a successful pop-up operatic performance of Acis & Galatea with Lyric Opera Theatre for EDGE Happy Hour on April 7-9<sup>th</sup>

- Art Tax: R. Remington, Luis Ruiz, and Shelley Hearn will be meeting with Steven Methvin, Andrew Ching, and City Council members over the next two weeks to discuss preparation of and to agendize the art tax. Details about the Art Tax include:
  - Staff is recommending a reauthorization of the Art Tax at the current level of 1/10 of 1% in perpetuity. This tax will fund the Arts + Culture Division, including Tempe Center for the Arts, Tempe History Museum, Tempe Public Art, historic properties, etc.
  - The art tax will be included in an upcoming City Council Work Group session. With Council's approval, the Art Tax could be on the March 2018 ballot.
  - TMAC members are welcome to attend City Council meetings as representatives of the Tempe community, voicing support for the importance of the Art Tax in the future of Tempe arts programming.

### Agenda Item 6 - Update: City Code Changes

- Maja Aurora gave an update to the changes in City Code as they pertain to merging History Museum Advisory Board members with TMAC to create the Tempe Arts & Culture Commission:
  - The changes were included in the April 6th City Council Work Study Session, to which Kelly Nelson and Peggy Maroney attended in support of the changes. The issue will be on the formal Council Agenda on May 4th, then again for vote on May 25th.
  - M. Aurora will send out the final agenda to TMAC members once they are available
- M. Aurora presented a recommendation from the City to move the officer elections from January
  to the December meeting. Voting on new officers in December and taking office in January would
  close a two-week gap in the current officer appointment method, which places officer voting and
  implementation in the same meeting in January.

- Rebecca Blume Rothman reported on current Tempe Public Art activity:
  - Highline Canal Multi-use Path public art project: 66 local and national artists submitted applications for consideration as the artist member of the design team. The artist selection panel happens on April 18th. www.tempe.gov/highlinecanal

  - Tempe Streetcar Public Meeting: April 19, 2017 @ 6pm in Don Cassano Room at Tempe Transportation Center, engineers will be presenting 30% designs for Streetcar stations and seeking public feedback. Artwork designs are in the making and will be presented at a future public meeting.
