Agenda Item 7 – Police Department Update

Commission Member Angel Carbajal introduced Police Commander David Humble who is interested in the work the Family Justice Commission is conducting.

Commission Member Angel Carbajal reported the following: In the first two (2) crime cycles of the year, there have been twenty (20) Sexual Assaults; the average over the last four (4) years is fourteen (14). Domestic Violence Assaults – 154; the average over a four (4) year period is 153. At the request of the Commission, Commission Member Angel Carbajal will report the updated statistics quarterly with April being the next report out. Commission Member Angel Carbajal expressed interest in providing an advanced sexual assault training to patrol officers. Commission Member Patrick Foster reported Arizona State University Campus Police will hand out information during Sexual Assault Awareness month with tips and information. The Patrol Officers will have their Police Department shirts retrofitted with a teal patch for the month of April. The Mayor's Proclamation for Sexual Assault Awareness month will be on Thursday, March 23, 2017 at 6:00 p.m. at Council Chambers.

Agenda Item 8 – CARE 7 Update

Commission Member Kristen Scharlau and Lauren Hyre recently received a grant to host a training conducted by Russell Strand in the fall. Two victim advocates from CARE 7 are attending the Crimes Against Women Conference in Dallas with four (4) detectives from the Special Victims Unit. A new Victim Advocate starts on April 3, 2017; funders approved to allow this counselor to begin immediate counseling for sexual assault and domestic violence victims. Counseling began a wait list with five (5) counselors on staff.

Commission Member Kristen Scharlau expressed the need to partner with a hotel to place emergency victims. Commission Member Kimberly Frick suggested Airbnb, Commission Member Kristen Scharlau stressed the need to build a relationship with a hotel. The Commission suggested contacting the Tempe Chamber of Commerce or community members acting as a foster family/safe family.

Commission Member Angel Carbajal recommended requesting additional funding for CARE 7 to increase staffing at the time the Commission presents to Mayor and Council for an Advocacy Center. The Commission suggested approaching the Arizona Psychological Association to create a volunteer pool of counselors to assist with the high demand of counseling.

Agenda Item 9 – Advocacy Center Tour Update

After a discussion with Paul Bentley, Human Services Director and Melissa Placencia, Administrative Assistant Commission Member Angel Carbajal reported the Commission will continue their regular monthly meetings as scheduled and the tours of advocacy centers will be separate. Mesa has confirmed and Phoenix will follow up with availability; a series of dates/times will be sent by staff via doodle pool.
