# Agenda Item 4 - NGO - Stronger Together AZ

Ashley Camhi introduced Stronger Together AZ Environment & Sustainability Committee to the Commission. She explained that they are an action and advocacy based group that fosters community service and civic engagement with over 8,000 residents throughout Arizona.

Their primary goal is to increase awareness of legislation at all levels of government. They would like to have more community involvement by partnering with school organizations, helping with government programs like adopt-a-park and outreach opportunities with the community.

### Agenda Item 5 – Hayden Butte Project

Bonnie Richardson, Principal Planner, gave an update on the Hayden Butte Preserve Management Plan, and shared some of the challenges and recommendations identified through the process. This is Tempe's first preserve management plan. Discussion about:

- Definition, education, maintenance and enforcement preserves
- Management plan will be created to provide a blueprint for :
  - Addressing the unsolicited requests the city receives for use of the Butte
  - Defining and controlling appropriate level of activities
  - Identifying improvements
  - Addressing challenges erosion, off trails activities, urban camping, graffiti and others
- This first preserve management plan may be followed by subsequent plans for:
  - Papago Butte
  - Bell Butte
  - Papago Regional Park (Tempe)
- Community Outreach was discussed
  - Stakeholder meeting March/April
  - Public open house April

# Agenda Item 6 – 5th Street

Eric Iwersen, Principal Planner, gave an update on the draft concept of the 5<sup>th</sup> Street Streetscape Plan. This concept reflects the collective feedback from the different Boards and Commissions sharing responsibility, the Sustainability Commission and the Transportation Commission.

Discussion ensued regarding the design, streetscape, low impact development techniques and traffic impact.

Next Public meeting is April 4th. Staff will present the concept to the City Council on April 6th.

### Agenda Item 7 – State of Neighborhoods Event

Braden Kay, Sustainability Manager, reminded the Commission that the Sustainability Award will be presented at the State of Neighborhoods on April 22nd. Deadline for the application award was February 15<sup>th</sup> and Commission will go through all applications at the next meeting. The event will spark a series of sustainability topics. There will be a series of efforts that residents can do on their own at home. Each session will last between three to five minutes, in different topics like energy upgrades, composting, water conservation, edible landscape, backyard chickens and how to activate your neighborhood.

Braden asked the Commission to send him any other suggestions.
