The Adaptive Parks working group's goal was to evaluate Tempe's progress on expanding the accessibility and inclusiveness of parks and playground experiences for children with disabilities and to design a strategy that would incorporate all-ability equipment elements where needed. Vice Mayor Arredondo-Savage seeks feedback to see if the board supports the Inclusivity Index adopted by the Committee of the Whole Working Group on Adaptive Parks that will be used to measure existing parks and playgrounds all-ability standards and guide all future playground designs and renovations. Overall the board thought it was a great idea as long as funding was also provided to support it.

#### All features are accessible

Design features a big white cloud roof with a flat surface underneath for accessibility. The water will cycle on/off and the structure includes some lighting elements as well. Ground features will be removable so that it can be used as an open venue during months not in operation. This item will come back to the board as it progresses forward for board input/comments.
