  - The vision is for the corner complex to be the "culture lab" of Tempe, offering live music, artist pop-up exhibits, and other creative focused events.
  - Neighborhood Economic Development Corporation is providing business assistance and serves as a resource for creative place making.
  - The development will be a mixed-income community built by Artisan Homes Inc., and feature some live/work units.
  - All of the 70 housing units will be affordable given that the property is part of a land trust. Half will be available to low-income buyers.

o In regard to the vacant city-owned building currently at the center of the complex, it may be used to feature murals and other types of artwork until demolition for development. This effort is considered an enhancement to the business environment and to business partners in the area.

#### **Mission Statement:**

A great city is defined by its arts and culture. The mission of the Tempe Arts & Culture Commission is to support an atmosphere in which arts and culture can flourish, and to inspire Tempe citizens to recognize arts and culture as essential to the whole life of our community.

#### Accomplishments (Past 12 Months):

With the formation of the Arts & Culture Division in 2016, Tempe Municipal Arts Commission spent months discussing necessary changes to the ordinance to reflect its future service to all workgroups within the division: Tempe History Museum, Tempe Center for the Arts, public art, arts engagement, and arts education. The results are the following: **Ordinance adoption:** Both TMAC and the History Museum and Library Advisory Board members were involved in discussions about proposed changes to the ordinance, which were approved by both boards in March and April 2017. The ordinance is the revised version adopted and in effect as of June 24, 2017. This Annual Report reflects TMAC information through June 23, 2017 and TACC information from June 24, 2017 to present. Commission members Jacque Tobias and Peggy Moroney moved from the Tempe History Museum and Library Advisory Board to join TACC in June 2017.

**Name Change:** Tempe Municipal Arts Commission was renamed Tempe Arts and Culture Commission. Commission members reviewed and discussed proposed changes to the ordinance and attended City Council meetings. Name change went into effect June 24, 2017.

There is a strong commitment to including artists, partners, community members, and stakeholders in the development or programming, and to intentionally serve the interests of their audience.
- Resourcefulness is the ability to find stakeholders and supporters, and draw on the core strengths of artists, partners, and participants. The budget shows a responsible and sustainable use of funding.
- Outcomes of programming align with program goals and have clear evaluation methods.
   The applicant knows who they are trying to serve with their programming and have clear methods and strategies of achieving their goal.

# TCA Excellence

(Maximum \$10,000)

#### Information

**TCA Excellence Grants** are available to non-profit organizations that develop artistically complex and rigorous programming, and provide impactful arts experiences to Tempe residents at the Tempe Center for the Arts (TCA). Eligible activities include the production of artistic performances, commissioning of new works, or continued innovation of existing performances. The grant supports a commitment to advancing Tempe as a vibrant and progressive community for cultural and artistic activity, and aims to fulfill the following recommendations from the Arts and Culture Plan:

- Increase and promote Community-Initiated Arts projects
- Expand co-productions, rentals and collaborations at the TCA
- Increase culturally diverse programming at the TCA

**AMOUNT:** Up to \$10,000

**ELIGIBILITY:** Non-Profit Organization

#### **CRITERIA**

- Quality is the ability to define and achieve artistic rigor and complexity within their artistic field(s), and provide rich sensory experiences for their audience.
- Community Impact creates collective meaning that transcends individual perspective and experience, and affords attendees access to collective experience, engagement and/or reflection. There is a strong commitment to including artists, partners, community members, and stakeholders in the development and presentation of artistic work, and to intentionally serve the interests of their audience.

# **FESTIVALS**

(Maximum \$10,000)

Arts Festival Grants support festivals that celebrate a community, neighborhood, or shared cultural interest with arts and culture programming. Festivals are regularly occurring events that build community through positive arts and culture experiences. Projects that are funded by this grant are held in public spaces and are accessible to the public. This grant supports a commitment to advancing Tempe as a vibrant and progressive community for cultural and artistic activity, and aims to fulfill the following recommendations from the Arts and Culture Plan:

- Support community festivals celebrating cultural diversity
- Support communitywide festivals of the arts and creativity
- Continue, expand and enhance informal arts programming provided in community settings

**AMOUNT:** Up to \$10,000

**ELIGIBILITY:** Non-Profit Organizations producing festivals in Tempe

#### **CRITERIA**

  aesthetic preferences. They provide rich sensory experiences, positive experiences
  amongst community members, and elicit stories, images, and perspectives of multiple
  individuals or stakeholders.
- Community Impact creates collective meaning that transcends individual perspective and experience, and affords attendees access to collective experience, engagement and/or reflection. There is a strong commitment to including artists, partners, community members, and stakeholders in the development and presentation of artistic work, and to intentionally serve the interests of their community.

# MINI GRANT: VIBRANT CITY

(Maximum \$750)

#### Information

**Vibrant City Grants** are intended to activate Tempe through the inclusion of arts and cultural participation, celebration of diversity, building community connections, and supporting local arts. 
