

## Lobbyist eFiling System Guide Expenditure Report for Organizations

- 1. Log in to the Lobbyist eFiling System, at <a href="https://lobbyist.tempe.gov">https://lobbyist.tempe.gov</a>.
- 2. Click on the "eFiling" button.



- Click on "Expenditures" for the appropriate Filing Year.
- 4. Enter the expenditure information.
- 5. After each entry, click on "Add Expenditure".
- 6. Once all entries have been added, click on "Preview Expenditure" to review the Expenditure Report before filing.
- 7. Click on "File Expenditure" to file the Expenditure Report.

At any time, click on "Main Menu" to return to the main screen.
