Call to Order

Agenda Item 2 - Approval of the December 13, 2017 Commission Minutes

- David Lucier asked the TMAC members to review an unapproved TMAC minutes document dated
 December 13, 2017.

Agenda Item 3 - Presentation & Discussion

- Rebecca Rothman, Public Art Administrator, presented information and updates about public art commissioned through the Maryanne Corder Neighborhood Grant (MCNG) program. Details include:
 - The MCNG program is administered by Neighborhood Services and available to Home Owners' Associations (HOA) and Neighborhood Associations (NA). When a grant is awarded for a public art project, the HOA/NA works closely with Tempe Public Art from planning through installation.
 - o In late 2016, City Council determined that all public art projects created through a MCNG should be maintained by Tempe Public Art staff, and therefore should be part of the Tempe Public Art collection if they are on city property.
 - Tempe Public Art has created a pre-qualified artist list through a Request for Qualifications (RFQ) and jury process. Selected artists are highlighted in a publication shared with HOAs and NAs, but not guaranteed a project.

- The Maryanne Corder Neighborhood Grant 2018 Pre-Qualified Public Artists list addresses the challenge many HOAs and NAs have in reaching, selecting and hiring a qualified artist through simplification of the process, while maintaining a grassroots process. The list includes biographic and contact information for each artist, along with samples of completed projects.
- The artist list will be published on the web with links and other pertinent information.

- O Neighborhood Services will include a hotlink for the artist list in their MCNG marketing efforts.
- 29 artists applied to the RFQ, 27 artists were selected for inclusion on the list. The selection panel for the list included TACC liaison Aaron Thacker and members of the community familiar with public art or the MCNG process.
- o Tempe Public Art would like the list to be live on or about January 22nd, 2018.
- The list will be presented to the public at the Maryanne Corder Neighborhood Grant workshop on January 24th at 6pm in Meeting Room A at Tempe Public Library.
- o In the future, the publication could become an artist registry for all types of public art projects.
- TACC members provided initial suggestions for edits that will be considered by the Tempe Public Art staff. Additional suggestions for edits must be received by January 17, 2018.

 - A flyer was distributed for Black History Month events at Tempe History Museum
 - Peterson House Museum:
 - A THM pop-up shop sold about \$2,000 in merchandise over the six days Peterson House was open in December.
 - Hayden's Ferry Questers Chapter #1245 is raising funds to assist with improvements to Peterson House, including a new, period accurate kitchen floor, to refinish the wood floors throughout, and to remove and perhaps replace the two aging exterior signs.
 - January through March Peterson House hosts Territorial Days tours for fourth graders.

 - Tempe Public Art is undergoing a compete assessment of the collection to determine a maintenance plan
 - Working with partners in IN FLUX to rethink the mission of the program to adapt to availability of vacant spaces

 a variety of upcoming arts programs related to the exhibit, including workshops and
 partnerships with high schools.
