Agenda Item 5 – Chair Remarks

The Commission welcomed new members JoAnne Del-Colle, Mary O'Grady, and Jill Oliver.

Karyn Lathan requested Agenda Item 6 – Tempe Family Justice Commission Officer Elections be conducted prior to Agenda Item 5 in order to have the appropriate Commission Member conduct the meeting.

Agenda Item 6 – Tempe Family Justice Commission Officer Elections

Paul Bentley conducted officer elections for Chair and Vice-Chair. City of Tempe employees Kristen Scharlau and Angel Carbajal are not eligible to be officer's.

Angel Carbajal nominated Karyn Lathan for Chair with no additional nominations. Karyn Lathan accepted the nomination. The Commission unanimously approved Karyn Lathan for a third term as Chair.

Judith Homer nominated Margaret "Peggy" Tinsley for Vice-Chair with no additional nominations. Margaret "Peggy" Tinsley accepted the nomination. The Commission unanimously approved Margaret "Peggy" Tinsley for a second term as Vice-Chair.

Agenda Item 7 – Victim's Healing Project Presentation Proposal & Discussion – Lori Robinson (attached)

Lori Robinson introduced herself to the Commission and shared a project she is working on to engage victims of sexual assault and domestic violence. JoAnne Del-Colle expressed concerns with the victims receiving treatment in a group setting. Lori clarified she would work closely with CARE7's Counseling Services to ensure they are receiving the therapeutic treatment needed in addition to "creative processing."

Agenda Item 8 – Discussion on Proposal for Tempe Family Justice Commission Donations

Paul Bentley was asked by Chair Karyn Lathan to research if the Tempe Family Justice Commission could receive donations for the purpose of raising awareness on issues of domestic violence, sexual violence etc. and special events. The City Attorney's office suggested partnering with a 501(c)(3) to receive donations on the Commission's behalf or to become a 501(c)(3). At the recommendation of the City Attorney's office, the Commission needs to formalize this request, present to Paul and then submit to the Mayor's office for discussion. This would allow Mayor & Council to discuss and decide. Vice-Chair Margaret "Peggy" Tinsley requested to meet with Mayor & Council with this request, Paul will put in a request to the Mayor's office to see if this is possible. JoAnne Del-Colle shared her positive experience with fundraisers and their success. CARE7 currently has a relationship with an organization that has embraced CARE7's Victim Services. The Commission discussed creating a subcommittee to create this proposal. After further review of the subcommittee guidelines, the Commission agreed not to move forward with the creation of a subcommittee and to add the proposal as a future agenda item.

JoAnne Del-Colle asked for clarity on the number of crimes reported for molestation of a child. Angel confirmed the number is accurate and noted the Commission has previously identified issues with crimes being under-reported.

Angel committed to report back to the Commission on further clarification of the number of crimes reported.

Agenda Item 11 – CARE7 Update

Kristen Scharlau reported CARE7 was awarded a \$2 million grant through the office of Victims of Crime Act Administrators (VOCA). This allowed the hiring of an additional victim advocate, a full time Counselor, Administrative Assistant and an additional outreach team working specifically with victims. CARE7 is looking at embedding a victim advocate in the Tempe Police Department's Homicide Unit. Lori Robinson is conducting professional development to all Tempe Union High School Counselors. Russell Stran will provide a free training at the request of CARE7 on February 21, 2018 at 9:00 at Marinalink at State Farm. The training is invitation only. Melissa Placencia will forward the information to the Commission.

Statement of Need



- 78% of cases served by victim advocates at CARE 7 are related to sexual assault and domestic violence.
- Individuals need safe spaces to process their experiences and begin to heal.
- Facilitated group dialogue and art making prove to support the healing process.
- Alternative forms of processing trauma are often not available.
- This is a unique way to both support and empower victims and raise awareness around the prevalence of this issue in our community.
 - There is growing awareness and sensitivity around these issues.

Project: Group discussion, creative processing, public awareness



- Therapeutic activities are difficult to access for many reasons.
- Group dialogue, art making (origami, beading, collage and painting)
- 10 week group, public event in May
- Support clients as they process and heal: self worth, focus, hope (connection)
- CARE 7 is uniquely qualified to provide this intervention with skilled staff, space, access, trust, strong community partnerships, and some funding.

Evaluation



- Pre-post survey
- Artist statement
- These quantitative and qualitative evaluation tools will measure the following areas:
- Perception of self (self worth)
- Emotional awareness
- Connection (feeling connected to self and community)

Research

- Connection between emotion and body awareness
- Creative expression helps focus on present moment
- Increases feelings of control and choice
- Values cultural diversity and lived experiences
- Creative expression promotes self confidence
 (there is never a right or wrong in creative expression)
