

# Minutes City of Tempe Sustainability Commission December 18, 2017

Vice Chair Jung called the meeting to order at 4:35 p.m.

#### Agenda Item 1 – Public Appearance

Vice Chair Jung asked for members of the public to introduce themselves.

# Agenda Item 2 – Approval of Meeting Minutes

Vice Chair Jung introduced the minutes of the November 20, 2017 meeting and asked for a motion. A motion was made to approve the minutes with an edit to include the name of Local First Arizona representative who attended the last meeting.

#### Agenda Item 3 – Recap Previous Presentations

There was no presentation to be recapped or that needs clarification.

#### Agenda Item 4 – Sustainable Business Opportunities

Braden Kay, Sustainability Manager, said there are two requests for sustainable business sponsorships. The Tempe Chamber of Commerce is requesting \$5000 for the sustainability pledge and Local First Arizona is requesting \$12,500 for three years for a sustainable businesses program. He made a correction from the previous meeting that funding in the commission's budget is not for marketing/sponsorship but rather for research and consultants. He said there are three options: (1) the commission could make the recommendation and staff will find funding in the existing budget or (2) the commission could make it an on-going request in the budget and he could submit a supplemental funding request that could get funded next year or (3) they could recommend the organizations apply for Innovation Fund money this year, a one-time pot of money for one-time applications.

The commission requested metrics to evaluate what these campaigns yield and said that a one-year commitment would be good so that the agency could come back and report on how the money was spent and provide metrics. Commissioners said they are looking for evidence that these campaigns work.

A motion was made to recommend sponsorship of \$5000 for the Tempe Chamber of Commerce Sustainability Pledge for one year from the existing budget. In one year, the Chamber will report back to the commission with metrics to evaluate the impact of the pledge.

A motion was made to recommend that Local First Arizona apply for the Innovation Fund and that the commission supports their application.

# Agenda Item 5 – Water Subcommittee Updates

Commissioner Monty gave an overview of the water subcommittee work and noted the Commission recommendation to accept the proposed 2018 water rates at a recent council meeting. Vice Chair Jung said the subcommittee worked on two documents, the values and guiding principles and the roadmap and strategies. He will send the documents to the commission and requested comments and edits by January 12th. Braden Kay, Sustainability Manager, said they will take the edited document and send it to Water Utilities staff for the next meeting and the commission can present it to Water Utilities staff.

## Agenda Item 7 - 2018 Neighborhood Awards - Sustainability Award

Braden Kay, Sustainability Manager asked the commission if they would like to have a Sustainability Award again this year to be presented at the State of Neighborhoods in April.

The commission thought it was successful last year and discussed doing it again this year. They discussed how to promote it. Braden Kay said he will get in touch with the City's Communications team and see how they would like to promote it.
