

PROPOSED PAPAGO PARK PRESERVE PUBLIC INPUT SUMMARY

The gathering and related comment card was purely informational and provides an equal opportunity for all viewpoints to be expressed. This opportunity, including the provision of all information, resources and staff, shall in no way be construed as any attempt to influence the outcome of any election, in violation of Arizona law, or otherwise.

Overview

A public meeting was held on August 2, 2017 to get feedback on a proposed Amendment to the Tempe City Charter that could ask voters to make Papago Park a preserve as well as an amendment to the Tempe City Code relating to preserve guidelines. Forty-four people attended the meeting. Surveys were available at the meeting and online on Tempe Forum from August 2 through August 27, 2017.

A total of 189 individuals read about the topic online at Tempe Forum with 62 of those submitting responses to the survey. Eight individuals also turned in a survey at the meetings totaling 70 responses. City staff also received emails about the project, some from individuals who also filled out an online survey.

I am not a lawyer and cannot comment on the strength of the document. I hope it is strong enough to pass the test of time and protect the beautiful natural desert so that many generations from now Tempe residents and visitors can enjoy the same activities and environment that we enjoy today. I hope that easements and encroachments to the preserve be somehow limited to the fullest extent possible.

Thank you for the opportunity to suggest the following changes.

Div 2, Section 23-110 - rules... (a) (1) Can hours be extended to allow those using the park for recreation in cooler hours? Hours could be different by season if needed. During this past summer, I walked at 5:30 each morning for a while because, in my opinion any later

was too hot for dogs. During my daily walks there were many others in the park at the same time. Would permits be available for those who want to use the park regularly outside of "normal" hours? If it is a liability question, can dark hours be "at own risk", and/or require personal lights to see and be seen?

Div 2, Section 23-110 - rules... 3)No motorized vehicles.... How does the recently passed e-bike ordinance in parks effect this? There are commuters who use the canal path between McDowell and Mill.

Div 2, Section 23-110 - rules... (4) No Camping...Should group camping permits for Evelyn Hallman Park be referenced here? Is this covered by section 23-112?

Div 2, Section 23-110 - rules... (7) No person shall...remove any live or dead tree or plant material in or from a preserve...Does adopting a park count as authorized by permit or permits by the Community Services Director? What about volunteers removing dead or "clipped" plant material? There are several of us in north Tempe who do the walkway creosote trimming in Evelyn Hallman Park. NTNA adopted Evelyn Hallman Park many years ago. PPVNA more recently adopted the east section of Lo Piano and part of the Canal Path north of Evelyn Hallman Park. As part of adopting the park areas, we trim creosote and palms from walkways, and sometimes clear invasive species during clean ups. We remove branches that have fallen or that the parks department cut. Would notice to/from the adopt a park manager be the authorization?

Section 23-111 (a) (6) Regarding bikes being prohibited where posted. This section is upsetting the biking community. Can there be some additional specific language? Include areas already posted at the time the preserve was created plus any specific reason a path would be permanently closed. For example, for safety reasons after erosion, or to preserve historical man-made artifacts that are in danger. Temporary closures posted for: rehabilitation of disrupted areas, trail maintenance, safety due to trail erosion, protection of historical artifacts. For permanent closure of a trail, can parks commission approval be required.

Section 23-111 (a) (8) Can we add an exception to the no fires or cooking; except for cooking food in city- provided cooking grills, or cooking food with commercially available camp stoves that use campfuel, propane, electric, or solar on or adjacent to a ramada table in a way to protect ramada and table. We currently cook and keep food warm for GAIN and other events in Evelyn Hallman Ramadas.

Fire only allowed in Evelyn Hallman Park Island in designated raised stone fire ring with a campfire permit and with wood brought in from outside of the preserve. No wood gathering permitted in the preserve. The Boy Scouts who built the fire ring, use the fire ring at least once a year for respectful flag retirement.

Section 23-111 (a) (2) Can we have cost reimbursement and fund raising sale/raffles for GAIN or other permitted neighborhood events? At times we raise small amounts to pay for event or donate to a cause.

Section 23-111 (a) (22) Can permitted events get permit for canopies in flat areas adjacent to ramadas or in parking lots? Game and Fish puts up a shade for their fishing clinic at Evelyn Hallman Park, adjacent to the ramada. Also, sometimes canopies are put up during adopt a park clean ups to provide shade over water and sign up tables.

Section 23-111 (a) (20) No Smoking - Thank you very much. Picking up filters is very time consuming.

Section 23-111 (a) (add?) Can glass bottles be restricted? Glass can be hard to pick up.

The base of Hayden Butte and at every lookout, glass is a problem.

I am also in favor of increased trail markers as I am often confused which paths are the designated trails.

While I like the idea of preserve hours being from sunrise to sunset for the benefit of wildlife, I feel that these hours would be too limiting for human recreation based on summertime heat and early winter sunsets. I am in favor of the preserve hours being restricted to 6am to 10pm, or even 5am to 10pm.

I feel that a board needs to be created to oversee management of the park, to include community members. Decisions about the preserve should not be left solely to the discretion of City of Tempe leadership.

Additional comments.

The designation of a preserve will be meaningless if patrols and maintenance of the area are not conducted regularly. I am appalled at the amount of litter and transient living that is STILL present in Papago Park. I would love to take family members who visit from out of town to the park, but I am currently embarrassed to do and also don't feel it's entirely safe, especially for young children.

Every time I visit Papago Park, I am in awe of the abundant amount of wildlife (birds, ground squirrels, rabbits, reptiles, etc.) that live in the park. We as a community should be very proud of this and work harder to protect this last remnant of wilderness within the city. I love that I can hike in the desert without having to leave Tempe and head to Scottsdale, Phoenix, or one of the county parks. I hope in the coming years the designation of a preserve will give this amazing area the respect, appreciation, and care that it deserves.

The adopted Discover Papago Park Master Plan outlines many different Sonoran environments, established trails, historic elements and the many current citizen uses in Papago Park. "The proposed Tempe Papago Park Preserve is NOT intended to eliminate or restrict those uses." Respect for the location and desert, especially staying on trails, no littering and following the rules would certainly be expected. Hiking and jogging are a daily occurrence in the park along with meditation and enjoyment of the environment. The intention is to both preserve and conserve Tempe's Papago Park and to preserve the intended uses of the park, while prohibiting development of the land.

Many miles of established equestrian trails are throughout Papago Park. Since Papago Stables is gone, other stables can bring horses into the park for scheduled trail rides. Currently, Tempe schedules Cross County Races and Mountain Bile Races in Papago Park. A Frisbie Golf range is located in the ravine just south of the Rolling Hills Golf Course and north of the SRP road. The Frisbie Golf members had to first clean up a bad dumping site in this area.

A map of existing trails, parking lots, disc golf amenities, playgrounds, restoration areas, etc. This would be in effort to prevent the building of new facilities, despite attempts to expand "recreational use". No splash pads, playgrounds, larger parking lots, new paved trails (see the 5K loop on the Phoenix portion). Allowing for language to include malleable recreational opportunities is a slippery slope to diminishing the park's natural desert footprint.

I like the fact that the city is thinking long term, which is more in line with the original Papago establishment.

I am concerned about a few issues. First, the sunrise to sunset restriction is limiting, especially with the excessive summer heat associated with daylight. Phoenix is going the other way and is extending evening hours to facilitate more usage. Evening usage also discourages dispersed illegal urban camping and the associated litter which has cost a ton of money and volunteer hours to clean up. Second is the undefined trail limitations with regards to bicycles. I support the establishment of a more defined trail system, perhaps with markings and revegetative areas, but banishment of bikes would not be acceptable. I ride in Papago at least weekly and spend money in restaurants every time. I would have to take my business elsewhere. I would also not support additional trail paving as Phoenix recently did on their section without appropriate citizen input. We have enough pavement everywhere else.

I would recommend continued support for the dirt jumps, and in fact would suggest a pump track. This encourages more youthful use, these youths are future adults whose support will be needed to preserve our open space in the future.

As one of the original petition circulators who supported initial efforts to establish Papago Park as a preserve, I am glad the Council has presented us with the option of enacting this charter amendment. There have already been proposals for a high-end housing development as well as a hotel within its boundaries. It is those kinds of threats to our public enjoyment of the park that prompted my initial involvement in efforts to prevent such development from being possible.

Please provide your comments on the proposed Amendment to the Tempe City Code, relating to preserve guidelines.

I support the proposed amendment to the city code with the following caveats:

1. Please do not restrict the use of the park to daylight hours. For at least half the year, the heat is excessive enough to make nighttime enjoyment preferable. Bicyclists and hikers can now use very efficient LED lighting to safely navigate the trails at night, when the heat is less severe. Most people work during the day, and for the cooler half of the year, the days are shorter and make it difficult to enjoy the park at all on weekdays without being there in the dark. One of the greatest deterrents to squatting and urban camping is park use by the rest of us. This is especially important at night. If appropriate park use by bicyclists and hikers is banned at night, inappropriate use will occur undeterred during those hours.

2. I see no mention of anti-littering in the code amendment. In fact, two former references to the use of glass containers have been removed. As someone who has volunteered several times to spend several hours picking up accumulated litter in the park, and who often does so even when such clean-ups have not been scheduled, I know that greater, not reduced, efforts are necessary to deter such abuse of this public space. Of course, enforcement is difficult, but without even a listing as an offense, can enforcement legally take place? The requirement that pet feces be appropriately managed by owners is excellent--why not regulate other litter, as well?

Additional comments.

Having read all the previous comments, many of them that express concerns about increased regulation are shared by me. However, I keep in mind that with increased population and shared use of limited spaces, responsibility must accompany freedom, lest all be deprived of the remaining resources. As a responsible citizen, I accept that I must be considerate of others, and that the purpose of regulations is not to interfere with my own enjoyment (though it may do so short-term), but to maintain the shared space so that all may enjoy it to the greatest extent without depriving similar enjoyment to others. No man is an island, and we must all compromise somewhat when living among others. Let's make Papago Park a preserve so that no one, especially a privately-owned hotel nor a housing development, can deprive all but a selfish, lucky few of what is rightfully ours to share mutually.

Section 23-101 (c) This wording appears to give the City free reign to build any facility they deem necessary. This is a concern because the proposed Preserve is not sufficiently large to support additional parking lots, ramadas, public bathrooms, or other large buildings without causing significant disruption to its usage. This wording could be rewritten to include the approval of a "citizen board". This would avoid future conflict over construction/development.

Section 23-101 (a)(1) We would like to see the park remain open as late as possible. 6am - 10pm seems appropriate. I understand there are safety concerns. Perhaps adding "no usage after sunset unless carrying adequate lighting". Not sure how that would sound or if it's a legal quagmire.

Section 23-111 (a)(2) This seems ambiguous and could be applied to horseback riding, trail running and mountain biking (which could be argued "endanger the health and safety of themselves or other preserve users). This will need to be clarified.

Section 23-111 (a)(6) I can understand the spirit of "where prohibited", but we need some sort of assurance "where prohibited" won't eventually include the entirety of the trail system. This is a rather large issue, and I can assure you this will lead to a host of "no" votes unless clarified. In fact, it would appear removal of this subsection would not be an

issue, since Section 23-111 (a)(10) already covers "off trail" access being prohibited for all activities.

Section 23-111 (a)(23) I suggest including "electric powered off road vehicles" as well. Section 23-113 (a) If this means that the Community Services Director can make sweeping changes without any input from the public I am against it. If this means the proposed amendment, when passed, can be changed to whatever this director sees fit, then why bother getting the public's input? Clarification, possible re- write, and restriction of authority needed. This Director's proposals must be subject to a citizen board.

There are tens of thousands of tourists who drive on the Loop 202 en route to some destination. You have the lovely Tempe Town Lake to the south, and on the other side of the 202, you have a unnaturally baron version of the Sonoran Desert on the north. It's like you have the "fake Arizona" with a lake, and the "real Arizona" with the nothing. Why can't this part of the park be upgraded with some natural landscaping? Saguaro, Palo Verde, Mesquite, etc. As an example of areas that have done it right... The NW corner of McDowell Road and Galvin Parkway used to be ugly dirt. Then they planted some natural plants and trees, and now it's gorgeous. https://goo.gl/maps/fHbZzjz2JSr . Similar natural landscaping was done on both sides of North Pima Road, just off the Loop 101 and heading into Carefree and Cavecreek.

- **5.** August 18, 2017 One of my concerns with the charter amendment as I understand the parameters, is that it does not protect enough of the current park from development. We know that developers have been interested in Rolling Hills Golf Course. We know that the Federal Patent was lifted to allow ASU to take possession of the old hospital in the middle of the park, and that property has been the subject of a class at ASU to find ways of monetizing that property with everything from hotels to mini homes. While I don't believe this mayor and council would entertain those projects, we need to protect all of Papago Park for future generations. Can we find a way to write the amendment to include preserving the whole of Papago Park's recreation, archeology and environmentally sensitive areas, which would contain the established picnic areas, fishing, hiking and biking on established trails, camping where permitted in Evelyn Hallman Park, protecting the sensitive natural desert vegetation and wildlife, and the Rolling Hills Golf Course? There has also been a lot of discussion about the ordinance Div. 1. Sec. 23-100. C. which allows the City of Tempe to determine without a vote by the city residents to make improvements where necessary. I think that ordinance is too vague, and weakens the strength of the Charter Amendment's protection of the park. Can we put something in the amendment limiting what the City can do without voter approval either spelled out or with a dollar amount? On the ordinances, Div.2 Sec.23-110, a-1, the Sunrise to Sundown provision I think is too subject to interpretation and would not allow residents who work to use the park in the winter. Increased activity in the Evelyn Hallman Park has helped with controlling the homeless camping in the park. Sec.23-111, a-8, I believe that cooking on city installed grills, as we have at Evelyn Hallman Park, should be allowed even without a permit. a-12. Which prohibits the sale of food and merchandise could also be prohibited for neighborhood events as well as recreational events. I don't understand why the sentences on glass bottles and litter were struck from a-22 & 23. Now the problem we have had with any park rules and regulations is enforcement. One Park Officer cannot do it! I am also summarizing my concerns on the forum page, but I wanted you to know my thinking. Thank you for all the work you and staff have put into this. It is a huge, but worthy project.
