**WE, THE UNDERSIGNED, COMPRISING THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, DO HEREBY CERTIFY, that a Primary Election was held in the City of Tempe on Tuesday, March 22, 1994 for the nomination of candidates to be voted for at the General Election to be held in said City of Tempe on the 10th day of May, 1994; for the election of Mayor for a term of two years; for the election of three Councilmen for a term of four years each; and for the election of one Councilman for a term of two years, to begin on the first regular meeting in July, 1994 or July 14, 1994.**


